Bidders are hereby notified that this Addendum shall be acknowledged on page <u>23</u> of the Bid Form and made a part of the above named bidding and contract documents. Bids submitted without acknowledgment of the Addendum will be considered incomplete.

The following items are issued to add to, modify, and clarify the quote and contract documents. These items shall have the same force and effect as the original quoting and contract documents, and cost involved shall be included in the quote prices. Quotes to be submitted on the specified quote date, shall conform to the additions and revisions listed herein.

## The following questions have been asked regarding this IFB:

QUESTION #1: Can you tell me if the absorbents are polypropylene type pads and if the rags are cotton or paper?

RESPONSE #1: The absorbent pads are polypropylene type and the rags are cloth (not paper).

QUESTION #2: C.04-Payment from vendor states that the vendor shall use a metered truck and record the gallons of waste oil collected and provide on-site receipt. Is it acceptable to use a tank stick to measure the tank level of the vendor's truck before used oil is collected into the vendor's truck, and measure it again after collection of the waste oil to determine the gallons of waste oil collected for each collection?

**RESPONSE #2:** No, due to the volume and frequency of collections.

QUESTION #3: C.04- Payment from vendor also states that copies of the hauling receipts shall accompany the payment. Our payments come back by check and a statement listing the dates and gallons that account for the payment, but not copies of the hauling receipts which are kept on file at our branch. Is this acceptable?

**RESPONSE #3:** The statement accompanying the payment must reference the hauling receipt numbers for which the payment is being made; otherwise, a copy of the hauling receipt must accompany the payment.
