A: The polymer identified as KED PA110VHM and KED PA110PWG has been tested and approved by the Manatee County Water Treatment Lab. Q: Provide the latest bid tabulation for the specified products within this bid package. A: Current bid tabulation attached. Advise the typical quantities purchased per release order and the total volumes purchased in the O: previous three year period for sodium percarbonate algaecide. A: Approximately 20,000 lbs are released per order with an average of 53,000 lbs per year over the last three years. These amounts may vary depending on the severity of the algae blooms in the lake. A: Manatee County currently uses Cedarfloc 510 for both surface and groundwater. Current pricing is \$1.95/pound. Q: Would the County consider revisions to C.11, "Warranty, Maintenance Service, and Support"? No A: Q: Would the County consider revising language in C.15 "Conditions for First Priority Service" indicating "best faith effort" in place of "first priority"? A: Manatee County shall remain "first priority" due to a public health issue affecting 300,000 citizens. Q: In reference to A.18 "Descriptive Information" would the County accept revised specification language, plus a Certificate of Analysis with actual test results delivered with each shipment? No A: Q: Would the County consider revisions to Section B.03, "Quality Guarantee"? No A: O: Will the County consider removing C.14.d, "Insurance – County's Protective Liability Coverage"? No A: Q: Regarding pre-testing and pre-qualification for IFB #12-2846BS Water and Wastewater Treatment Chemicals, specifically, are only the polymers that were trial tested in March 2012 and September 2012 acceptable or are equivalent products acceptable to bid. If so, is any pre-testing required? A: Only products tested in March and September will be accepted.
