

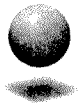


Dear Bidders:
