## **ACTION DESIRED**

Authorization to rescind award of IFB #13-0297CD, Solid Waste Cover Dirt, on an "as required basis" made to 72 Land, LLC, Myakka City, FL on January 10, 2013 and re-award to the second lowest, responsive, responsible bidder, SMR Aggregates, Inc., Sarasota, FL for a bid of \$6.44 per cubic yard for an estimated total amount of \$915,000.00

## **BACKGROUND/DISCUSSION**

- On January 10, 2013, IFB #13-0297CD was awarded 72 Land, LLC Myakka City, FL as the lowest responsive, responsible bidder at a bid of \$4.50 per cubic yard.
- After award, and prior to rendering any services, 72 Land, LLC requested a price increase. After being notified that they
  could not have a price increase, 72 Land, LLC indicated that unless the County revised the contract to allow for a price
  increase, 72 Land, LLC would not be able to perform the work awarded to them.
- On January 25, 2013, a termination for default notice was issued to 72 Land, LLC, Myakka City, FL.
- Article C.02 of the bid documents states the bid award may result in similar quantities of purchases, as listed on the bid form page, and that Purchase Orders would be issued on an "as required" basis covering all or part of the specified items on bid.
- The estimated quantity listed on the bid form is 173,000 cubic yards. SMR Aggregates, Inc.'s bid amount of \$6.44 per cubic yard allows the County to purchase only an estimated 140,000 cubic yards within the approved budget.
- SMR Aggregate, Inc. has agreed to honor their unit price bid amount of \$6.44 per cubic yard for an estimated 140,000 cubic yards of solid waste cover dirt.
- The procurement of the solid waste cover dirt is funded from the landfill operating supplies budget 4800010900-552000.

Recommend rescind award of IFB #13-0297CD, Solid Waste Cover Dirt to 72 Land, LLC, Myakka City, FL and Re-award to SMR Aggregates, Inc., Sarasota, FL for an estimated total
