Manatee County invites your participation in the following quotation for auto parts at various Manatee County locations.

### **PURPOSE**

It is the intent of this quote to establish a three-year term agreement (renewable annually) between Manatee County Government and auto parts suppliers for a firm fixed price for automobile parts on an "as required" basis. Vendors may quote on <u>any or all</u> of the groups as listed.

### **CLARIFICATION**

It shall be the responsibility of all quoters to request any additional clarification of the contents herein from George Earnest, Buyer. Clarification deadline is February 18, 2013 at 3:00pm, with no requests allowed after that time. Clarification will be furnished by written addendum from Purchasing. Quoters shall not accept any verbal or telecommunication explanation as authorized clarification of the contents herein.

### **RENEWAL**

If not cancelled by the Vendor or the County, this term agreement shall be automatically extended/ renewed beyond the first 12-month contract period for two additional 12-month optional periods not to exceed a total contract duration of 36 months. Should a vendor wish to cancel the term agreement, written notice with as much advance notice as possible will is requested. Should the Vendor choose not to renew the term agreement, the County reserves the right to terminate the Contract with that Vendor and select the next qualified quoter, or re-advertise for those quote items, or solicit a new Request for Quote for any or all items (including multiple awards).

### **SPECIFICATION**

Vendors must submit quotes strictly in accordance with specifications. Each variance to these specifications must be specifically stated by the vendor on the quote form. Should the vendor not furnish the County a list of exceptions and supporting data, the County will assume the vendor is quoting in accordance with the specifications.

### QUALITY GUARANTEE AND REMEDIAL CLAUSE

If any product does not meet specifications the contractor will be required to rectify any and all products involved in the unsatisfactory situation. If the unsatisfactory products involve other contractors who are blameless, then it shall be the responsibility of the contractor responsible for furnishing of unsatisfactory products to reimburse the blameless contractors for any and all additional work or expense required due to the faulty products.

### **QUALITY TERMS**

Manatee County reserves the right to accept or reject any and/or all work or materials used in the work, if in its judgment the work or materials reflect unsatisfactory workmanship, or manufacturing defects.

### WARRANTY

The vendor shall provide factory warranty for all parts purchased as a result of this quote, from date of delivery acceptance.

### **BLANKET ORDER**

Blanket Purchase Order(s) shall be issued as a result of this request for quotation. A Blanket Purchase Order number, when accompanied by a valid Release Order number provided by an authorized County employee will authorize purchases on an "As Required" basis.

### CANCELLATION

The purchase order (contract) shall be subject to immediate cancellation, if either product or service does not comply with the specifications, terms, or conditions stated herein. Products or services which do not comply with the specifications, terms or conditions stated herein will be returned and no payment for such defective items shall be due.

#### **AWARD**

Award will be made to the lowest responsive, responsible quoter having the lowest Grand Total price **per group** meeting specifications. Quoters shall quote each item within a group to be considered responsive for that group. The County reserves the right to make multiple awards.

Whenever two or more quotes which are equal with respect to price, quality and service are received, a quote received from a local business shall be given preference in award. Whenever two or more quotes which are equal with respect to price, quality and service are received, and both quotes or neither of these quotes are received from a local business, the award shall be determined by a chance drawing conducted by the purchasing office and open to the public.

Local business is defined as a business legally authorized to engage in the sale of the goods and/or services to be procured, and which certifies within its quote that for at least six (6) months prior to the announcement of the solicitation of quotes it has maintained a physical place of business in Manatee, Desoto, Hardee, Hillsborough, Pinellas or Sarasota County with at least one full-time employees at that location.

### MINIMUM TECHNICAL SPECIFICATIONS

### **PURPOSE**

It is the intent of the County to purchase on an "as required basis," automotive and truck parts for delivery to various locations in Manatee County. It is the specific purpose of this quote to establish an annual contract for automotive stock inventory, and to secure the cost and availability of the materials.

### QUANTITIES

The exact quantities of the required supplies cannot be determined at this time, but approximated past annual usage is indicated on the Quote Form pages for certain high turnover items. This quote may result in similar quantities of purchases; however, this is not guaranteed. Similar items may be added to the stock list throughout the term of the agreement as needed.

Annual blanket purchase orders shall be issued as a result of this bid.

### **DELIVERY TIME**

All deliveries shall be made between the hours of 8:00 AM and 3:00 PM, Monday through Friday, excluding holidays to the following designated locations. Large shipments, e.g., truckloads requiring material handling equipment, must be preceded by no less than 24 hours notice.

Important/Please Note: Vendor shall provide a separate delivery ticket for each delivery and/or service, and will obtain receiving signatures from the County representative. At least one copy of the delivery ticket shall be left with the County's representative on each delivery. Invoices shall be sent to Manatee County Clerk of Court as detailed on the purchase order. Payment cannot be authorized without a copy of this ticket signed by a County representative.

### **PRICES AND TERM**

Quoters shall bid unit prices, FOB destination, including all discounts in accordance with the unit of quantity indicated on the Quote Form. The prices quoted shall be current at the time of submittal. Prices quoted shall be used to include payment in full for all transportation, labor, fuel and equipment used in delivering all supplies to the point of delivery.

The unit of measure (UM) shall be Each unless otherwise indicated on the Quote Form and items shall be priced in accordance with this UM.

The County reserves the right to request additional items to be added to a group during the term of the agreement. This shall be done through a quote request from the County and a written response from the Vendor to establish the price of any new items.

### PRICE ADJUSTMENT

Prices shall remain firm for the first 12-month contract period. After that time, requested price increases are not guaranteed. Price increase requests must be in writing and will be considered by the County in the month prior to renewal. Increases must be justified by the vendor based on prevailing market conditions at the time.

### CONFORMANCE TO SAFETY RULES AND REGULATIONS

Vendors must conform to all site rules and regulations affecting the work. These include but are not limited to: keeping public areas free of waste materials, removing all rubbish that the vendor is responsible for before leaving the premises and strictly adhering to all Local, State and Federal safety codes.

(a) Whenever a responsible local business quoter and a responsible non-local business quoter are found, upon the opening of quotes, to have both submitted the lowest responsive quote, the quote of the local quoter shall be awarded the contract. Should more than one responsible local business quoter match the responsible non-local business quoter's lowest responsive quote, or should no responsible local business quoter match the lowest responsive quote but two or more responsible non-local business quoters submit lowest responsive quotes for equal amounts, then the award of the contract shall be determined by a chance drawing, coin toss, or similar tie-breaking method conducted by the purchasing office and open to the public. Any quoters seeking to be recognized as local businesses for purposes of this local business preference provision may be required by the terms of the quote announcement to certify they meet the definition of local business set forth in this section, and to register as a local business with the county in the manner prescribed by the county to facilitate the county's ability to track the award of contracts to local businesses and to allow the county to provide future notifications to its local businesses concerning other quoting opportunities.
