Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein

The deadline for clarification of questions is <u>March 29, 2013 at 3:00 pm.</u> This deadline has been established to maintain fair treatment of all potential bidders. Questions received after this date and time shall not be considered.

1. Two bids are due one for 90 days and one for 120 days, is that for the complete job or only the metal building erection part of the job?

2. If its 90 days or 120 days does that start once the concrete sub is finished? So my question is when does that period start?

3. If liquidated damages are \$388 per day after 90 days, are there any bonuses for getting it done sooner? Weather permitting the job should not take us more than 2 weeks.

The County will pay for the permits; however, the contractor shall submit 5 sets of signed and sealed shop drawings to Property Management, which will be then submitted to the Building Department to complete the permit package.

5. Do we supply the as-built record drawings if we are only doing the steel erection?

Yes.

6. What is the R-value of the 2" insulated wall?

R-14.9

- 7. Are there any stairs going to the attics or safety rails across the edge of the attics?

 No.
- 8. Roll up doors colors and building color?

To be determined from manufactures standard color chart.

- 9. Spec calls out for a 20 year weather tight warranty on the roof and walls. There is not a weather tight warranty available on a screw down roof and no wall weather tight warranty exists.
 - 1.9 Q to read "Weather tightness warranty 20 years on Standing Seam Roof Panels". This paragraph is on page 5 of the Pre-Fabricated Steel Building Specifications.
- 10. Are the exhaust fans part of this bid package? If so please provide a spec with model numbers.

No., the exhaust fans are not part of this bid package.

11. Will the requirement for bonds be waived?

No, the requirement for Bid Bonds and Performance and Payment bonds will not be waived. See Sections C. 15 and C.16 of the Invitation for Bid.

13. Is there any specs for the doors and hardware for the exterior doors?

There are two exterior doors to be a part of the Pre-fabricated Building. One exterior door on the north elevation, the other exterior door on the south elevation. Both doors are located between column lines 2 and 3.

Both doors are $3 \times 7 \times 1-3/4$ ", hollow metal with vision light, with hollow metal frames. Reinforce door and frame for magnetic locks.

14. Can other roll up door providers be used that meet the specifications, other than Overhead Door Company?

Yes, other door providers may be used as long as they meet the specified specifications in the Invitation for Bid.

- 15. Overhang---no soffit L12 soffit mentioned see page 8 of specs. Soffit on overhang?
 - Provide soffit panels on all overhangs and canopies as specified in the Specifications Section 2.6 Exterior Panels, paragraph D. Soffit panels are not required at the Garage 12 foot overhangs only.
- 16. Tongue and Groove--inconsistent language in plans/tech specs. Please define and amend.

Plywood Decking on the two attic frames will be furnished and installed by others.

17. Gavalume, define what finish to use.

Contractor shall submit manufactures actual Kynar color chips for the County's selection.

18. On sheet S2--note in the center of plan---please clarify.

The Contractor is requested to provide separate costs for each attic frame as noted on the Bid Form.

Anchor bolts upfront---add to scope of requirement? 4 interior columns will be bolted to footing? Does the bid form change--if it changes then the technical specs as to where to place it to capture costing will need to change as well.

Anchor bolts required for the attic frames are to be included as part of the frame cost. Anchor bolts and templates shall be furnished to the site prior to placing the concrete slab, by others, and prior to the frame delivery.
