Demolition of Digesters #1 and #3 at SWWRF

ADDENDUM #1

Bidders are hereby notified that this Addendum shall be acknowledged on page $\underline{00300-1}$ of the Bid Form and made a part of the above named bidding and contract documents. Bids submitted without acknowledgment of the Addendum will be considered incomplete.

The following items are issued to add to, modify, and clarify the bid and contract documents. These items shall have the same force and effect as the original bidding and contract documents, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

1. **CHANGE** the third paragraph of Article D.01, The Work, on page 00100-1 of the bid documents to read as follows:

The price for the tank cleaning portion of the project shall include all labor, hoses, high powered vaccum trucks, pressure washer, all required ppe equipment, to remove any and all remaining grit material in accordance with state and federal regulations.

It is anticipated that as much as 3200 cubic feet of grit material will be remaining in each tank after being drained by the County. The Contractor shall use the drying pads at the Southwest Water Reclamation Facility to dry and decant the grit material before transporting to the Lena Road Landfill for disposal.

The Contractor shall haul the dried and decanted grit material to the Lena Road landfill for disposal, and shall be paid for actual tons hauled. The scalehouse at the Lena Road Landfill will provide the Contractor's driver with a ticket showing the amount of tons hauled for each delivery. Manatee County will pay the tipping fees.

- 2. **DELETE** the Bid Form page 00300-2, and INSERT the REVISED Bid Form page 00300-2 that is attached to this Addendum #1.
- 3. CHANGE the Due Date and Time to Friday, April 19, 2013 at 3:00 PM.

The following questions have been asked regarding this IFB:

QUESTION #1: Can we utilize the adjacent property berms or dikes for temporary placement of the steel tank lids during the digester lid demolition procedure.

RESPONSE #1: No berms or dikes shall be used; however, some of the other adjacent property may be designated for staging with approval from the County's Engineer team at the preconstruction meeting.

QUESTION #2: Can we pump wash water and de-canted liquids from the recovered solids into an onsite lift station? If so, how far is the closest wastewater lift station or entry point?

RESPONSE #2: Yes. Plant drain stations are just east of Digesters No. 1 and No. 3.

QUESTION #3: Since we have no analytical on the sludge, are we to assume that the decontamination portion of the project is to be completed by 40 Hr OSHA HazWOper train personnel?

RESPONSE #3: The sludge at the SWWRF is classified as domestic, and it is anticipated that the majority of the material remaining in the digesters after they are drained by Operations will be grit and "rags". However, it will be the responsibility of the Contractor to perform a Toxicity Characteristic Leaching Procedure (TLCP) on the remaining sludge material before tank cleaning to accurately determine if the sludge material is hazardous. OSHA 40 Hour (HazWOper) training is not necessary if the Contractor determines that the sludge material is considered to be non-hazardous.
