Bidders are hereby notified that this Addendum shall be acknowledged on page 00300-1 of the Bid Form and made a part of the above named bidding and contract documents. Bids submitted without acknowledgment of the Addendum will be considered incomplete.

The following items are issued to add to, modify, and clarify the bid and contract documents. These items shall have the same force and effect as the original bidding and contract documents, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

1. **CHANGE** the first sentence of Article B.03, Qualifications of Bidders, on page 00020-2 of the bid documents to read as follows:

No person who is not certified or registered as a General Contractor or Building Contractor pursuant to the terms of Florida Statutes Chapter 489 on the day the Bid is submitted, and who has continuously held that certification or registration for a period of at least three (3) consecutive years immediately prior to the day the Bid is submitted, may be qualified to bid on this project.

2. **CLARIFICATION** of anticipated grit material remaining in each tank, and the location of the drying pads as described in item #1 of Addendum #1:

Based on previous digester tank cleanings done by Utilities Operations, it is anticipated that the remaining grit material will be in an upside down cone measuring half of the tank diameter and approximately ten feet in height.

The drying pads are located within a hundred yards of the Digester Tanks.

3. **DELETE** the REVISED Bid Form page 00300-2 issued with Addendum #1, and **INSERT** the REVISED Bid Form page 00300-2 that is attached to this Addendum #2.


