• The Anna Maria Island Project is a Federal shore protection project with a 50-year lifespan. The initial restoration was constructed between December 1992 and February 1993, with the first periodic renourishment completed in June 2002. Approximately 2.3 million cubic yards of sand were placed on the beach along 5 miles of Anna Maria Island in 1991, and approximately 1.8 million cubic yards along 5.1 miles in the cities of Bradenton Beach and Holmes Beach, and .6 miles are within the City of Anna Maria. While federally authorized, the City of Anna Maria portion was not federally funded but cost-shared with the State of Florida.

Manatee County expects the second periodic renourishment to be completed in 2019 to last through the design period of eight years; however, the complete range of services identified in B.02, Scope, will be required to prepare for the third periodic renourishment expected on or before 2022.

Professional engineering consulting services are needed to assist Manatee County with all aspects of the project for Anna Maria Island and any other coastal or tidally influenced shoreline in Manatee County.

• The Request for Proposal was posted on the County website, DemandStar, advertised in the Bradenton Herald and Tempo News and provided to the Manatee County Chamber of Commerce for distribution to its members. Three (3) firms listed below alphabetically submitted proposals.

Coastal Planning & Engineering, Inc. - Boca Raton

Coastal Technology Corporation - Vero Beach

Gahagan and Bryant Associates, Inc. - Tampa

• The Evaluation Committee convened on 2/19/2013 and short listed all three (3) firms and requested Oral Presentations as listed alphabetically below:

Coastal Planning & Engineering, Inc. - Boca Raton

Coastal Technology Corporation - Vero Beach

Gahagan and Bryant Associates, Inc. - Tampa

Oral Presentations were conducted on 3/14/2013. Afterwards, the Evaluation Committee convened
to discuss the offers based on the stated requirements in the RFP, continuing the acquisition
process and determining a recommendation to the County Administrator of Coastal Planning and
Engineering, Inc.

- Coastal Planning & Engineering, Inc. the top ranked firm was founded in 1984 and now is staffed with
 48 in house professionals. The in house staff is such that no outside Subconsultants are required to
 perform the County's work assignments. Coastal Planning & Engineering, Inc.(CPE) has successfully
 performed 70 beach renourishment projects across the United States which is more than any other firm
 of this type. CPE is a leader in new technologies for this type of service such as numerical modeling,
 engineering modeling, coastal geology and surveys, Lidar specialists and the invention of adjustable
 Groins. The total team proposed was, in the Evaluation Committee's opinion, the most impressive and
 experienced of the presenting firms.
- Gahagan & Bryant Associates, Inc. the #2 ranked firm established in 1975 is a well known entity with nine offices located on the East Coast of Florida. They demonstrated an extremely high level of talent and expertise in the services required by the RFP. Only one of their subconsultant team members was in attendance to which the Committee could address questions. The overall presentation provided was well received but was not of the level of information provided by Coastal Planning & Engineering, Inc. Their local experience is extremely low, as compared to the other two presenting firms, and of a great concern to the Evaluation Committee.
- Coastal Technology Corporation the #3 ranked firm includes three (3) subconsultants to complete their proposed team and to give them the depth of staff required to fulfill the County needs, however only one of those subconsultants was in attendance at the Oral Presentation. The overall presentation was not of the caliber of the other two presenting firms and fell short of the Evaluation Committee's expectations due to the lack of total team participation at the Oral Presentation and the perceived team weaknesses when compared to the expertise of the top two (2) ranked firms. This firm was established in 1986 and we are confident that their services are adequately provided to their existing clients but would not be the best choice for Manatee County.
- The estimated range of cost for the initial year of the Agreement is \$100,000.00.
- The above justifications are a generalized summary of major observations intended only to provide the
 County Administrator a sufficiently detailed overview of the main observations of a majority of Committee
 Members. Each Committee Member may have considered one or more facts or factors more or less
 important than other Committee Members when voting, and this summary of the Evaluation Committee's
 decision is not an attempt to exhaustively describe each of the relevant factors which motivated each of
 the Committee Members to select the rankings described.
