SUBJECT: ADDENDUM #1– Request for Quotation #13-1508BS,
Outdoor Fitness Equipment

Quoters are hereby notified that this addendum shall be acknowledged within their quote and shall be made a part of the above issued Request for Quotation. This information is issued to add to, modify, and/or clarify the Request for Quotation documents. These items shall have the same force and effect as the original Request for Quotation. Quotations are to be submitted on the specified date and shall conform to the additions and revisions listed herein.

Q: Is two person equipment a requirement of this RFQ?

A: Yes, two person equipment is a requirement of this project.

Q: What is the project budget or estimate for the outdoor fitness equipment?

A: This is a budgeted project. The estimated budget for the fitness equipment is \$6,800.00.

Q: Will all three installation sites accommodate a tractor?

A: Yes, the Conservatory Park trail provides tractor accessibility; however, the awarded contractor will need to stage the truck/tractor/trailer outside of either park entrance because neither parking lot is wide enough for a u-turn.

Q: Will the 8" dirt dig out need to be removed from the park by the awarded contractor?

A: No, the project manager will designate an area(s) for the dirt to be relocated within the park. Manatee County will be responsible for leveling the dirt.

Note: Manatee County will provide geotextile fabric (underlayment of the engineered ADA mulch) and flexible plastic or fiberglass molding (approximately 4"-6" high and any necessary staking) for the perimeters of all three installation sites. The awarded contractor shall incorporate the installation only into their quotations.

Note: The awarded contractor shall prepare all three site locations based on the dimensions provided by the Manufacturers specifications. Please specify these dimensions on your quotation form.
