Q1. Has the above project been declared permit exempt?

R1. The section of Bowlees Creek has been previously dredged and the work is deemed as deminimum. See General Note 2 of the plans: The construction activities performed in accordance with the construction plans and specifications are anticipated to have a minimal impact and would be deemed exempt or as deminimus activity. Construction activities must cease and applicable regulatory state and federal permits/authorization must be obtained should construction activities be deemed necessary to deviate from what is noted on the approved plans and specifications.

Q2. I read the project plan and did not see how many cubic yards were projected to be dredged. Is there a project amount?

R2. Approximately 590 Cubic Yards are to be dredged.
