BACKGROUND/DISCUSSION

- The Property Management Department has a requirement for the purchase and installation of a new Sports Lighting System for two existing soccer fields at the Lakewood Ranch Park Complex.
- The Invitation for Bid (IFB) involves the complete installation of a new County supplied lighting system that was approved for purchase on March 16, 2009 under IFB #09-0485CD.
- 4/24/09 to 05/11/09, appropriate bid procedures were followed. Notice of the Bid's availability was posted on the Manatee County website, Manatee County Chamber of Commerce's website as well as sent directly to eight (8) local firms, as defined by section 2-26-6(c) of the Manatee County Purchasing Code, via fax and email. Six (6) bids were received.
- This is procurement for specialized electrical services for the installation of specialized lighting for athletic sports fields, and there are a limited number of Manatee County electrical contractors that have the experience and capability to perform these services. Although notified of the bid opportunity, four (4) Manatee County contractors chose not to respond.
- The Property Management Department reviewed the bids submitted and on 05/13/09 their recommendation was received to award to the lowest responsive, responsible bidder.
