These items shall have the same force and effect as the original bidding and contract documents, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

Based upon instructions from the Project Manager, Mr. Mike O'Reilly, Manatee County Government, Public Works Department, Mr. Dave Schofield, Utilities Distribution Superintendent and from Mr. Jim Stockwell, Senior Project Manager.

- Q1. Could you please clarify your local contractor preference? Does it only apply in cases of a "tie bid", or does it apply to bids also, where the local contractor is within a certain % of the non local bid?
- A1. **Answer:** Please see E.02 (Section 2-26-6, Local preference, tie bids, Local business defined) pages 00200-2 through 00200-3.
- Q2. Is there stimulus money involved on this project?
- A2. Answer: There is no stimulus money in this project.

- Q3. Bid Item 11 has five check valves? Can't find?
- **A3.** Answer: Bid item 11 should be corrected to read "18"x16" Tapping Sleeve, 1 Each", there are no check valves required in this project. Please see revised Bid Forms attached. Contractors are to utilize these forms when submitting their bid package.
- Q4. Are temporary jumpers needed? If so what size?
- **A4. Answer:** Temporary jumpers are required per Manatee County Standards (2009) UW 21 and UW22. The minimum. size is 2" dia. jumper, but larger may be required to obtain minimum flushing velocity required by AWWA (3.0fps min., 3.5fps preferred) for disinfection.
- Q5. EPDM gaskets per new county code may not be available. If not available will need an alternate installation plan.
- **A5**. **Answer:** EPDM gaskets are required. If not available they will need to be special ordered.
- Q6. Pay items call for 4 tie ins. One of which is the 20 x 16 tap sleeve. Pay item should change to three.
- **A6. Answer:** There is no need to change the quantity for pay item # 10, the 20 x 16 Sleeve, the quantity of one (1) is correct. The other three connections require an 18 x 16 Tapping Sleeve, an 8" cut in tee, and a 6" cut in tee.
- Q7. Air release valves, above the pipe or are they offset to side of road?
- **A7. Answer:** Air Release Valves are to be installed as shown on the plans. Most are above the pipe, but where the pipe is under pavement, the ARV is offset to the side of the road. No manholes will be required to house ARV's under pavement.
- Q8. The specs call for the pipeline to be pigged however there are Butterfly valves in the line and they cannot allow a pig due to the disc being in the middle of the pipeline when open. Please advise what you want done to address this?
- **A8. Answer:** The contractor can pig each section of the line between valves as he proceeds to install it, rather than wait until valves are installed, to avoid the pig hitting valves.
