### BACKGROUND/DISCUSSION

- This procurement is for silvicultural product consulting services, brokering services, harvest sales of existing, silvicultural and overly dense natural forested areas (thinning) to be inclusive of timber, mulch, stump materials or other forest products up to and including native ground cover seed material in County owned preserves and all associated contents as identified and directed, planting containerized genetically approved tree / seedlings, and burn management.

- The term of this agreement is sixty (60) months with two additional sixty (60) month agreement periods. The total agreement may be up to one hundred eighty (180) months.
- The annual estimated expenditure is \$246,000.00.
- The County solicited Request for Quotation #14-2888BS Silvicultural Planting / Harvest Sales and Services from October 24, 2014 through November 13, 2014, appropriate quotation procedures were followed.
