Bidders are hereby notified that this Addendum shall be acknowledged on the Bid Form and made a part of the above named bidding and contract documents.

1. A second visit is scheduled for **1:00 P.M. on February 12, 2015**. Interested bidders will meet in the parking lot of the project site located at the Supervisor of Elections, 600 301 Boulevard West, Suite 108, Bradenton FL (County contact at site: Angela Honts).
2. To accommodate the SOE staff, the construction schedule shall include completion of Phase 2 prior to Phase 3 and shall provide one (1) week for SOE staff to relocate to Phase 2 area.
3. Work hours for this project is specified in IFB Specification Section 011000, Summary 1.7.B Work Restrictions. A Charge Back Rate of \$75 per hour shall apply to contractor's requested time beyond the normal business hours specified. The Charge Back Rate shall not apply for shutdowns required after hours; however, 72 hours written notice is to be provided for approval.
4. A background check of contractor's employees is not required for this project. Please delete all reference to this requirement in IFB Specification Section 011000, Summary 1.7.H.
5. Building permit fee of \$5,900 is the responsibility of the contractor.
6. The asbestos survey shall be provided to the awarded contractor by the County.
7. Replace Table of Contents with the attached corrected Table of Contents (for correction of project title).
8. Deadline for Clarifications Requests is 5:00 PM on February 20, 2015. Attached page A-3 is corrected to reflect this date.

9. Information Conference sign-in sheet for attendees is attached.
10. Engineer's estimated construction cost for this project is \$490,000.

If you have submitted a bid prior to receiving this addendum you may request in writing that your original, sealed bid be returned to your firm. All sealed bids received will be opened on the date stated.

All additional lands and access thereto required for temporary construction facilities or storage of materials and equipment are to be provided by successful bidder. Easements for permanent structures or permanent changes in existing structures are to be obtained and paid for by Owner unless otherwise provided in the IFB documents.

Failure to become familiar with Project Site conditions will in no way relieve the successful bidder from the necessity of furnishing any materials or performing any Work that is required to complete the Project in accordance with the Project Plans and Specifications. Bidder shall acknowledge inspection of the Project Site(s) on his/her signed, submitted Bid Form.

A.05 MODIFICATION OF BID DOCUMENTS

If a bidder wishes to recommend changes to the IFB documents, the bidder shall furnish, in writing, data and information necessary to aid Owner in evaluating the request to modify the IFB documents. Owner is not obligated to make any changes to the IFB documents. Unless an addendum is issued, the IFB documents shall remain unaltered. **Bidders must fully comply with the IFB documents in their entirety.**

A.06 CLARIFICATION & ADDENDA

Each bidder shall examine all IFB documents and shall judge all matters relating to their adequacy and accuracy. Any inquiries, suggestions or requests concerning interpretation, clarification or additional information pertaining to this IFB shall be made through the Manatee County Purchasing Division. Owner shall not be responsible for oral interpretations given by any Owner employee, representative, or others.

5:00 PM on February 20, 2015 shall be the deadline to submit to the Purchasing Division, in writing, all inquiries, suggestions, or requests concerning interpretation, clarification or additional information pertaining to this IFB.

This deadline has been established to maintain fair treatment of all potential bidders, while maintaining progression of the Work.
