ADDENDUM #2

Bidders are hereby notified that this Addendum shall be acknowledged on the Bid Form and made a part of the above named bidding and contract documents.

1. Bid Opening is extended to March 3, 2015 at 3:00 P.M., same location.
2. **QUESTION:** In reviewing bridge span lengths, drawing calls for 15' span length in the middle of several bridges. Specifications call for Top Down construction. Can 15' span length be reduced to a maximum of 10' to accommodate Top Down construction?

RESPONSE: As long as changing the center span to 10' does not require any permit modifications and there are no additional pilings in the water with a 10' span, the County does not object to a reduction to a 10' center span for pedestrian bridges. Any permit modifications as a result of variance from the permitted drawings are the responsibility of the contractor.

3. Bids shall be submitted in Triplicate, one original and two copies.
4. **Question:** The Table of Contents refers to a Technical Specifications section with 14 pages. We are unable to locate. Is there a Technical Specification Section?

RESPONSE: Technical Specs and Section D are the same. Delete reference to Technical Specification on Table of Contents page.

5. **QUESTION:** Section D.1.8 states that Pensacola Bahia sod shall be used on areas to be sodded, There is no Pensacola Bahia sod available around this area. Argentine Bahia sod is readily available in this area. Can Argentine Bahia sod be used instead of the Pensacola sod?

RESPONSE: Argentine Bahia sod will be accepted for use on this project. However, note that Paragraph 2 of Section D.1.9.2 states sod containing Bermuda grass will be rejected.
