This deadline has been established to maintain fair treatment for all potential bidders, while maintaining the expedited nature of the Economic Stimulus that the contracting of this work may achieve.

Engineer's clarification to Addendum No. 1:

Question 1: Response 4, if we are cutting in a new tee, what is the distance to the nearest upstream valve? We need to know the volume of raw sewage we will have to handle when we cut into the existing force main.

Response 1: The nearest upstream valve is approximately 740 LF to the west at the existing lift station. Please note, the existing 6" force main has a total length of approximately 3,653 LF. From the record drawings, the high point of the force main is approximately 2,665 LF downstream from the lift station. If the record drawings are 100% accurate, the proposed cut-in tee is at the first 750 LF of force main, this means there could be approximately 2,665 LF of existing 6" force main to generate raw sewage to be handled.

Question 2: Response 8, does not directly answer the question regarding telemetry equipment, but if the current existing control panel houses the existing telemetry equipment and if we are to just relocate the existing control panel, then we will not need a new pump control panel correct? Plan Sheet 7 of 11, LIFT STATION PROPOSED CONDITION detail, shows a NEW CONTROL PANEL, are we to furnish and install a new pump control panel?

Response 2: Plan sheet 7 of 11 has been revised and is attached. The contractor shall be responsible for relocating the existing control panel, install new conduit and wiring to the wet well. The County will relocate the antenna after the contractor has relocated the control panel, the County shall be responsible for telemetry equipment and associated wiring. The County shall connect all wiring inside the relocated control panel.

Question 3: Response 9, if we are to exclude the cost of new pumps, what about base elbows, guide rail system, floats, lifting cables, hatch cover, etc., are we to furnish these?

Response 3: Yes, furnish and install. The contractor shall be responsible for furnishing all items associated with the new above ground lift stations and all items mentioned above with the following exceptions: the County will furnish and install the actual pumps, relocate the antenna & telemetry equipment and associated wiring; the Contractor shall relocate the existing control panel, install new conduit and wiring to wet well. Contractor shall furnish and install all items required to have a fully functioning, operating lift station, (lift chains are required, not cables). New landscaping and fencing will not be required.

If you have submitted a bid prior to receiving this addendum, you may request in writing that your original sealed bid be returned to your firm. All sealed bids received will be opened on the date stated.
