ADDENDUM #1

Bidders are hereby notified that this Addendum shall be acknowledged on page Bid Form-1 of the Bid Form and made a part of the above named bidding and contract documents. Bids submitted without acknowledgment of the Addendum will be considered incomplete.

The following items are issued to add to, modify, and clarify the bid and contract documents. These items shall have the same force and effect as the original bidding and contract documents, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

1. **CHANGE** Article C.01, Minimum Qualifications of Bidders, on page C-1 of the bid documents to read as follows:

Each bidder must possess all licenses required (in accordance with Chapter 489 Florida Statutes) for the Work which is the subject of this bid; and, upon request, shall submit a true copy of all applicable licenses. **The bidding Contractor (company supplying the bid) shall be an FDOT Pre-Qualified Contractor in the categories of “Drainage, Flexible Paving, and Underground Utilities (water and sewer)”.**

The bidders corporate name must appear in the State FDOT database in all of these categories on the Bid due date. In addition, the certifications must be maintained throughout the duration of the project.

2. **DELETE** Bid Form pages Bid Form-2 thru Bid Form -4 and **INSERT** the REVISED Bid Form pages Bid Form-2 thru Bid Form-4 that are attached to this Addendum #1.
3. **CHANGE** the Due Date and Time to **Wednesday, July 15, 2015 at 3:00 PM.**

The following questions have been presented by potential bidders:

Question #1: Will all pipe restraints be required to have stainless steel tie rods?

Response #1: All underground bolts, nuts, and washers shall be COR-TEN or stainless steel (*Reference Manatee County Utility Standards section 1.11.2.J*).

Question #2: Reference page 7 of the Special Conditions: Subsoil Excavation. Should any unsuitable material be found, how is the unsuitable material to be quantified for payment?

Response #2: Please see the Revised Bid Form attached to this Addendum #1.


Question #3: Reference Plan Sheet 4: Corner of 12th St 7 55th Dr. E. - Note for Tree Protection. Can the County provide a tree protection plan to follow?

Response #3: All trees within R/W and easement limits shall remain unless otherwise noted; any roots over 1" diameter, to be pruned, must have a clean cut; a certified Arborist from the County shall be present during all root pruning (Ted Cresswell 941-345-2044 (cell) or 941-708-7467 (office)); the cost for tree preservation and root pruning to be paid for as part of the unit price for pipe.
