BACKGROUND/DISCUSSION

This project is a Local Agency Project (LAP) funded by FDOT Financial Project ID No.: 429871-1-58-01 and required prior approval of the bid and contractor by FDOT. The Work consists of widening Morgan Johnson Road (57th Street East) @ SR64, enclosing the drainage ditch, storm sewer construction and modifications to the traffic signals at SR64 in order to accommodate dual left hand turning movements and a combined through right hand turning movement. Also included in this Scope of Work is milling and resurfacing of the intersection and roadway.

Appropriate Bid procedures were followed. Notice of Bid availability was advertised on mymanatee.org, DemandStar and the Manatee Chamber of Commerce.
