ADDENDUM #2

Bidders are hereby notified that this Addendum shall be acknowledged on the Bid Form and made a part of the above named bidding and contract documents.

- 1. Engineer's construction cost estimate is \$1,379,527.
- 2. Sign in sheet for Information Conference is attached.
- Addendum 1: Inspection of the project site is a prerequisite for award (reference Bid Article C.02 Basis of Award). Schedule visit by 5:00 P.M., March 7, 2016 to ensure site access. Contacts: Bill Elmore at 941.792.8811 extension 5010 or Christen Trine at 941.722-6683.
- Question: Can DR-17 be used instead of DR-11?
  Response: Yes, DR-17 may be used for the main pipe. The contractor shall ensure the Inserta-tee product is compatible.
- 5. Question: Can the existing utilities be added to the plans. Response: Where possible, the existing utilities have been visually shown on the plans. However, as stated in the notes on Sheets 3 thru 7, all existing utilities generally run in the "right-of-way" at the back sides of all the mobile homes. The Contractor shall assume all existing utilities are in the vicinity of the sewer gravity mains and must be located before excavating.
- Question: Will there be structural repairs on the manholes. Response: No stand-alone structural repairs to the manholes walls are proposed. Per the contract documents, there are structural repairs associated to the primary scope of work:
  - Structural repairs related to the pipe bursting process/installation are considered part of the scope of work and shall be included in the pipe bursting Bid Item 3.

- 6. (CONTINUED)
  - Structural preparation for the rehabilitation/lining of the brick manholes per Section 02627 or required by the manufacturer's recommendation shall be included in the rehabilitation Bid Item 2.
  - Structural repairs for reinstated and realigned sewer services shall be included in the sanitary sewer service Bid Item 4.
  - The bench of the manhole(s) shall be repaired as required to provide the typical "U-channel".
- Reinstated sewer service connection locations shall be placed per the general notes of Sheet 9 and located in accordance with the direction of Colony Cove maintenance personal, George, 941-705-6683. Colony Cove personal are very familiar with the current and future "parcel" needs of the mobile homes.
- Sanitary sewer services direct to and terminating in a manhole shall be reinstated and redirected to the new HDPE main. The remaining service hole(s) in the manhole then shall be mudded up and lined over.
- 9. Record Drawings: The area marked "This Portion Excluded from Project Future Phase" may also be excluded from the record drawing requirement.

10. Plans: Sheets 3 thru 7 attached: Revised Notes. Added available existing utilities.

If you have submitted a bid prior to receiving this addendum you may request <u>in writing</u> that your original, sealed bid be returned to your firm. All sealed bids received will be opened on the date stated.
