What is the response time requirement for occasional "rush" requests?

Answer:

Within twenty-four (24) hours of notification.

Question:

What is the percentage of septage vs grease?

Answer:

Estimate – 60% grease, 40% septage

Question:

Hours estimated for FY2015 Monday through Friday 8am - 5pm = 35 hours and Monday through Friday 5pm - 8am, holidays & weekends = 5 hours. Does this cover going to location, pumping traps, taking to dump,

and returning to base.

Answer:

No, these estimates are for arriving at specified County location, pumping traps, and completing the services at the dump. Portal to Portal invoicing

is not acceptable.
