### Background Discussion

It is the intent of the County to establish annual agreements to procure, on an "as required" basis, Sanitary Sewer - Lateral Lining Rehabilitation Services. The proposed services may include, but not limited to, TV Inspection and computerized analysis, lateral rehabilitation which may include cleaning and inspection, sewage bypass pumping, reestablishing service connections, maintenance of traffic, surface restoration and any associated work required to complete a project in accordance with the Invitation for Bid. The County solicited on MyManatee.org, Manatee County Chamber, and Demand Star. Formal competitive sealed bid procedures were followed resulting in three (3) bids as identified on the attached bid tabulation.
