FPL requires a minimum 30-day notice to have this work completed by FPL staff. The County shall be copied on all coordination efforts with FPL.

Interactive <u>REVISED</u> Excel Bid Forms for "Bid A" and "Bid B" are made a part of this Addendum No. 1. Revised Bid Items: Palma Sola Woods 1 – Bid A & B, Items 23 and 45; Hawthorn Park Bid A & B, Items 41, 42, 43 and 44. (22 total pages attached)

Bidders Note 5:

Although an Information Conference for this project was not held, questions requiring clarification of the project were received from the bidders. These questions are through June 13, 2016 at 12:00 PM. Responses to the questions are made a part of Addendum No. 1.

WILDWOOD SPRINGS 2 / RTU 115

- **Q1.** What is the power service voltage?
- R1. The power service voltage is 230 volt / 1 phase.
- Q2. What is the existing pump horse power?
- R2. The existing pump horse power is 4.5 hp
- Q3. Will a ROW permit be required for the driveway installation to Oakview Dr?
- **R3.** Yes. The application must be completed, reviewed, and approved. There are no fees to the Contractor.
- Q4. RTU 115 plan sheet 4, PROPOSED PLAN VIEW, this view shows the new discharge pipe in the same direction as the existing discharge pipe. Reference plan sheet 5, the PROPOSED PLAN VIEW, shows the above ground valve assembly concrete pad in a different orientation than plan sheet 4, what direction are we to figure installing the new discharge pipe? If we are to install as shown on plan sheet 5, then more information regarding location of existing 4-inch force main is needed. Please clarify.
- R4. Typically in our rehabilitations there are no site modification to be done and a generalized configuration is shown along with the note 1 on Sheet 4, top left corner, which states, "The wet well and valve vault configuration shown on these graphics is for identification of components to be removed. The Contractor shall field verify all existing conditions, elevations, configuration, etc for accuracy. Sheet 5 has been provided, since there are site modification proposed for Wildwood Springs 2. The site plan shall be followed and, if necessary, modified as needed by the County Inspector to adjust for unknown conditions. Unfortunately, there are no record drawings available for this station, but we are certain the force main exits the north side of the existing valve vault.

- Q5. Wildwood Springs 2 RTU 115 bid form, bid item 38, Viburnum Hedge, what about mulch and irrigation system? Please clarify.
- **R5.** Mulch and irrigation is not required as part of this project.
- Q6. Reference Wildwood Springs 2 RTU 115 bid form, bid item 20, 4" D.I. Flanged Adapters, the bid quantity is for one (1) each, shouldn't this be two (2) each?
- R6. No. The quantity for bid item 20 has been reviewed and the correct quantity is one (1) each.
- Q7. Please provide a detail for rebar reinforcement for the new wet-well tops and concrete pads for above ground valve assembly.
- R7. Please refer to the Manatee County Public Works Standards. All Contractors are encouraged to have a copy for reference. These documents are available on http://www.mymanatee.org/home/government/departments/publicworks/engineering-services/engineering-standards.html for download in a portable document format (.PDF). Per the attached version of "sewage Pump Station Section View (US-19)", the reinforcement is called out to be a #4 bars@ 10" on center each way with two inches minimum cover top and bottom. The rebar should be embedded in 4,000 psi concrete, type II cement.
- **Q8**. What is the thickness of the new wet-well tops supposed to be?
- **R8.** The thickness should be 10" per the Manatee County Public Works Standards.
- Q9. Will a project sign be required at each lift station site?
- R9. No, Project signs are not required on these rehabilitations.

- **Q10**. Palma Sola Woods 1 RTU 214, plan sheet 6, the fiberglass valve vault, please provide contact information for the manufacturer of this vault.
- R10. One such provider is Barney's Pump, (863)-665-8500.

- 11R. Yes it should. Bid item 45 has been revised from SY to LF.
- 12Q. What is the power service voltage?
- **12R.** The power service voltage is 230 volt / 3 phase.
- 13Q. What is the existing pump horse power?
- **13R.** The existing pump horse power is 2 hp.
- 14Q. Will a ROW permit be required for the driveway and curb installations to 75th St West?
- 14R. Yes. The application must be completed, reviewed, and approved. There are no fees to the Contractor.

AZALEA PARK - RTU 246

- 15Q. Azalea Park RTU-246 lift station, is there a force main coming from the west into this lift station? If so, what size is it and what kind of flows does the station it is from have?
- 15R. Per our record drawing and County staff inspection, there are no force mains discharging directly into the Azalea Park lift station. Per the record drawings, a 6" HDPE force main does discharge into the manhole north of the lift station. The 6" force main originates from a private lift station and should discharge approximately 175 gpm. Since this is a private station, we have no records of the pump's activities.

HAWTHORN PARK – RTU 251

- 16Q. What is the power service voltage?
- 16R. The power service voltage is 230 volt / 3 phase.

- **17Q.** What is the existing pump horse power?
- **17R.** The existing pump horse power is 3 hp.
- Will a ROW permit be required for the driveway installation to 92nd St N.W.? 18Q.
- Yes. The application must be completed, reviewed and approved. There are no 18R. fees to the Contractor.
- Sheet 10 of 13 shows 2 locations for "PROPOSED CONTROL PANEL". Is there another 19Q. Item at the site that requires 2?
- The rectangular box north of the valve assembly is mislabeled. The rectangular box is 19R. supposed to represent the relocated BFP, meter and hose bib. There is only one control panel proposed.
