ADDENDUM #1

Bidders are hereby notified that this Addendum shall be acknowledged on page 22 of the Bid Form and made a part of the above named bidding and contract documents. Bids submitted without acknowledgment of the Addendum will be considered incomplete.

The following items are issued to add to, modify, and clarify the bid and contract documents. These items shall have the same force and effect as the original bidding and contract documents, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform with the additions and revisions listed herein.

1. **CHANGE** the first paragraph of Bid Article E.02, Bidders Qualifications, on page 21 of the bid documents to read as follows:

E.02 BIDDERS QUALIFICATIONS

Reliability of the vendor's past service will be evaluated to determine acceptance of the lowest priced responsible bidder. Vendor shall have sufficient financial support, equipment, ability, and organization to ensure that they can satisfactorily execute the services under the terms and conditions stated herein. The vendor must be able to provide an FDEP approved and permitted site for land application, in the event that this option must be used, at the time of their bid submittal. Bidder shall provide three commercial references for which you are performing or have performed that are similar in nature to requirements specified herein.

2. **CLARIFICATION** of Bid Article D.07.5, Vendors Responsibility for Land Application, on page 17 of the bid documents:

The Vendor is responsible for providing an FDEP approved and permitted site for land application at the time of their bid submittal. For more information on FDEP approved and permitted sites for land application of wastewater cake sludge, the vendor should contact the Florida Department of Environmental Protection at 850-245-8734.

3. **CLARIFICATION** of Bid Article D.04, Estimated Quantity, on pages 15 and 16 of the bid documents:

The quantities listed in this article represent the highest historical output. The output from October 2007 thru September 2008 for each facility is as follows:

Southwest (SWWRF) = 23,200 cubic yards; Northwest (NWWRF) = 4,700 cubic yards
Southeast (SEWRF) = 13,000 cubic yards

4. **CLARIFICATION** of Bid Article D.01, Vendors Responsibility to haul to Landfill when sludge is not suitable for Bio-Solids Dryer Facility or Land Application, on page 15 of the bid documents:

Hauling to the landfill will be done in an emergency basis only, and when this occurs the County shall be responsible for the landfill tipping fees.

5. **CLARIFICATION** of Bid Article D.05, Vendor Personnel and Equipment, on page 16 of the bid documents:

The vendor will be allowed to use roll-off bins only if the roll-off bins will work with the current dumping bins at the Bio-Solids Dryer Facility.

6. **DELETE** the Bid Form page 22 of the bid documents, and **ADD** the Revised Bid Form page 22 that is attached to this addendum.

7. **CHANGE** the Bid Opening Date to **Tuesday, January 20, 2009 at 2:00 PM.**

The following question was asked at the information conference on December 19, 2008:


Question 1: Can a site visit be scheduled, and if so what is the contact information?
