### ENABLING/REGULATING AUTHORITY

Pursuant to Section A.12, "Reserved Rights," of the Request for Proposal, the County is publishing notice of its decision to reject all proposals received in response to the above-mentioned RFP and cancel the RFP due to budgetary reasons.

### BACKGROUND/DISCUSSION

#### PROJECT BACKGROUND:

The intent of the Request for Proposal was for a selected Proposer to provide beach trash collection services. The objective of the RFP is to increase operational efficiency, engage citizens with disabilities, and provide an immediate positive impact on beach visitors. The work consists of providing beach trash collection services seven (7) days per week, Monday through Sunday from 8:00 AM to 5:00 PM. The Selected Proposer shall furnish all services and labor necessary to conduct and complete the services described in the RFP. The Selected Proposer shall be responsible for cleaning all trash receptacles every day or to a standard acceptable to the County and provide a work schedule detailing the specific daily services to be performed.

#### SOLICITATIONS:

The RFP was advertised on the Manatee County website, DemandStar, and was also provided to the Manatee County Chamber of Commerce for release to its members. Four (4) proposals were received.
