

The following items are issued to add to, modify, and clarify the bid and contract documents. These items shall have the same force and effect as the original bidding document, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

The deadline to submit all inquiries concerning interpretation, clarification or additional information pertaining to this bid was December 16. 2016 at 5:00 PM. No additional questions shall be considered. This deadline has been established to maintain fair treatment for all potential bidders, while maintaining the expedited nature of the Economic Stimulus that the contracting of this work may achieve.

Bidders Note 1: Utility Permit No.: 2016-H-194-231 for the above project approved by FDOT, Albert Rosenstein on December 14, 2016. (19 pdf pages attached)

<u>Bidders Note 2:</u> Successful contractor shall coordinate the fiber relocation from the existing conduit system over to the new conduit system with the School Board. This **<u>MUST</u>** be done in advance as the fiber supports the schools in session. The relocation may occur over a weekend.

Bidders Note 3: Questions received from the bidding community through December 16, 2016 at 5:00 PM.

Question 1: The County is asking for Professional Liability Insurance to be provided. Is this correct?

Response 1: Remove requirement for Professional Liability Insurance. This project is for construction only. All work shall be performed in accordance with the specifications and plans provided. No design requirements will be required of the contractor.

Question 2: Section B, Scope of Work B.01 states that "During construction of FDOT's project, FDOT's contractor shall remove all existing conduit not in use by the FDOT contractor." Please clarify. Does this bid include any removal or grout filling of existing Manatee County IT conduit? Does this bid include any removal of existing Manatee County IT fiber optic cable, pull boxes or splice boxes?
