NOTICE OF INTENT TO AWARD

Noncompetitive notice of Intent to Award task 20170921 for the procurement of services to remove vegetation and sludge from retention ponds to EPB Enterprises, LLC located in Sebring, Florida (\$33,656.67).

ENABLING/REGULATING AUTHORITY

BACKGROUND/DISCUSSION

- ✓ This procurement is for cleaning and removal of vegetation and sludge from two (2) backwash retention ponds and cleaning of the swale area in accordance with specifications provided by Manatee County.
- ✓ This is an annual maintenance requirement of the ponds and swale areas. Services includes all mobilization, demobilization, equipment, appurtenances and labor.
- ✓ EPB Enterprises provides water-tight dump trucks. The sludge being removed is a slurry, which is pumped into the trucks and disposed of onsite, as directed.
- ✓ The County requires water-tight dump trucks to transfer the sludge / slurry and the Utilities – Water Division is not aware of another contractor that can meet this specification.

If a vendor believes this item is not a sole source or noncompetitive procurement, Manatee County Purchasing Division requires prospective vendors provide information regarding their ability to supply the commodity or contractual services described prior to the date indicated for "date contract shall be awarded".
