BACKGROUND/DISCUSSION

The Public Safety Department's Emergency Services software used by Manatee County requires yearly maintenance and support services. Intergraph Corporation is the provider of the Computer Aided Dispatch (CAD) software product which supports the County's Emergency Services. The Intergraph Corporation product was developed using their intellectual property and source code. This information is proprietary and no other vendor offers substitute support and maintenance services to this product.

The Public Safety Department requires Edge Frontier Software and custom Automated Secure Alarm Protocol (ASAP) inorder to interface to the Alarm Companies utilizing Intergraph's Computer Aided Dispatch(CAD) System.

No other vendor can create this interface from the Intergraph CAD System to the Alarm Companies since Intergraph owns the source code to the CAD System and related interfaces. This software must communicate with the Intergraph Computer Aided Dispatch(CAD) System which is used by Public Safety Dispatch Center. No other vendors' software could work in the Public Safety Dispatch Center environment since it is not compatible with the existing CAD software.

If a vendor believes this item is not a sole source procurement, Manatee County Purchasing Division requires prospective vendors provide information regarding their ability to supply the commodity or contractual services described prior to the date indicated for "date contract shall be awarded".
