ADDENDUM #1

Bidders are hereby notified that this Addendum shall be acknowledged on page 00300-1 of the Bid Form and made a part of the above named bidding and contract documents. Bids submitted without acknowledgment of the Addendum will be considered incomplete.

The following items are issued to add to, modify, and clarify the bid and contract documents. These items shall have the same force and effect as the original bidding and contract documents, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

1. **CHANGE** Article D.01.A.6, Entrance Gate, on page 00100-3 of the bid specifications to read as follows:

Entrance Gate

Dual swing aluminum gate manufactured by Gate Depot, Inc., Circle Series #4 (Bell Curve) 28 ft wide x 84½ inches at high point in center, 72½ inches at low point, black powder coated. The typical gate drawing may be obtained at http://www.gatedepot.com/gates_aluminum/image/aluminum_driveway_gates_c4_500_px.gif. Please use the sketch drawing of the gate, attached to the bid documents, for dimensions, bar sizes, and spacing of rungs.

2. **CLARIFICATION** of Article D.01.B.4 on page 00100-4 of the bid specifications:

The tree protection plan from a Certified Arborist is to pertain **only** to the protection of the trees during the scalping of the existing parking lot base, as described in Article D.01.B.5 on page 00100-4 of the bid specifications. The Certified Arborist is expected to be on site during this phase of construction to assist the Contractor with which roots may or may not be cut for the health of the tree(s), should a root be impacted by this process. Maintenance of the trees is not to be a part of the tree protection plan for this project.

3. **CHANGE** Article D.01.B.6 on page 00100-4 of the bid specifications to read as follows:

Finished grade of parking lot may be above current parking lot grade; however the finished grade of parking lot and sidewalk shall not exceed finished floor elevations of existing restroom and pavilions to the south of parking lot. In addition, the finished grade shall be so that no water drains onto the parking lot property from the entrance at 17th Avenue and the water on property shall drain to the southwest corner of the parking lot.

4. **DELETE** Bid Form pages 00300-2 thru 00300-9 and **INSERT** Revised Bid Form pages 00300-2 thru 00300-9 that are attached to this Addendum #1.

The following is a question asked after the informational conference held on January 20, 2010:

Question #1: Entrance Gate as specified under Spec Section 00100-D.01G mentions Article D01.A.5 (which is D01.A.6) calls for a Gate Depot Circle Series#4. The dimensions noted do not match the sketch included with the bid documents. Please identify which dimensions are to be used. Also please clarify the height required for the gate posts.


RESPONSE #1: The dimensions on the sketch, attached to the bid documents, are the correct dimensions to use (Please see item #1 of this Addendum). The heights of the gate posts, described in Article D.01.G on page 0010-6 of the bid document, are to be eight feet above ground.
