## **Action Requested**

Authorization to award IFB 16-3095OV, Glass Fused Steel Equalization Tanks, to the lowest, responsive, and responsible bidder, Vogel Bros. Building Company, Lakeland, FL, for a total of \$7,210,500.00 based on a construction completion time of 390 calendar days.

Authorize the County Administrator, or his designee, to execute the Agreement and accept and date the Performance and Payment Bonds.

## **Background Discussion**

This project consists of constructing three (3) 1.0 million gallon equalization storage tanks at the North Water Reclamation Facility (NWRF), 8500 69th Street East, Palmetto, FL. In addition to the equalization tanks, the project includes a new equalization return pump station, site piping improvements, flow splitter box modifications, prefabricated electrical/storage building, platform, walkway, stairs, demolition, electrical instrumentation, and controls.

Formal competitive sealed bid procedures were followed resulting in a total of five (5) bidders submitting a sealed bid for consideration per the attached tabulation of bids.

On March 14, 2017, Project Management Division staff recommended award to the lowest, responsive, and responsible bidder, Vogel Bros. Building Company, Lakeland, FL, in the amount of \$7,210,500.00, based on a construction completion time of 390 calendar days.

Budget Amendment B-17-037(6) to fully fund the project will be presented to the BCC on April 4, 2017.
