BACKGROUND/DISCUSSION

- The Work included in this Request for Quotes (RFQ) consists of furnishing all labor, materials, and equipment to maintain 94 acres of 87 county ponds and swales in three levels of service: Tier 1, 2 & 3.
- Provided that there are no changes in price, terms or conditions, this contract may be renewed past the initial one-year (1) period for four (4) additional twelve (12) month periods not to exceed a total duration of sixty (60) months.
- As a result of a competitive quoting procedure, a total of three (3) quoters submitted a quote for consideration. The attached Quote Tabulation provides the breakdown of the responses received.
- Additional locations and sites may be added or deleted during the term of the contract at a per cut price.
- On April 6, 2017 a recommendation was received from the Public Works Department recommending award to Duval Landscape Maintenance, LLC for Tier 1, and Amerson Landscape for Tiers 2 & 3.
