## **Background Discussion**

This project provides for replacement of an aging force main which serves as a critical connection that ties into two major force mains. Project location along 44th Avenue West (Cortez Road) within the north right-of-way from a master lift station west of 86th Street to 66th Street, turns south to run along 66th Street to the Southwest Water Reclamation Facility.

Formal competitive sealed bid procedures were followed resulting in a total of seven (7) bidders submitting a sealed bid for consideration per the attached tabulation of bids.

On April 5, 2017, Property Management staff recommended award to the lowest, responsive, and responsible

bidder, Pospiech Contracting, Inc., in the amount of \$6,510,961.88, based on a construction completion time of 570 calendar days.
