CLARIFICATION

- 1. The Lockwood Ridge Road location (site 6) requires an appointment for inspection. Please contact Kathleen Barrett at 941-742-5980 x1876.
- 2. The Detention Facility (site 2) has been removed from this solicitation.
- 3. The County is revising the scope of work to <u>include</u> (in additional to Category 1) Category 2 invasive-exotic species, nuisance plants and potato removal in accordance with the Florida Exotic Pest Plant Council (EPPC) guidelines for all locations listed on the quotation form.
- 4. Japanese climbing ferns were found on the berm at the Lockwood Ridge location (site 6). This species has been added to the quotation form. Treatment must be scheduled as a priority.

There is no access to the hammock area at the Lockwood Ridge Road location (site 6). This location has been put on temporary delay until access can be provided to the Successful Quoter by the County. Please provide a treatment price on your quotation.
