



BACKGROUND/DISCUSSION

- It is the intent of the County to establish an annual agreement(s) to procure on an "as required" basis Veterinary Drugs & Supplies and miscellaneous related items.
- As a result of formal competitive sealed bid procedures, one (1) bidder submitted a sealed bid for consideration. Suncoast Surgical & Medical Supply shall be awarded groups 2, 3 and miscellaneous catalog items. Suncoast Surgical & Medical Supply did not bid on groups 1, 4, 6 and 7 and were deemed non responsive for group 5 because they did not bid on 75% of the 215 items listed.
- On July 3, 2017, an email was received from Manatee County Animal Services, a division of Public Safety, recommending award of groups 2, 3 and miscellaneous catalog items to Suncoast Surgical & Medical Supplies of Tampa, Florida for a total estimated amount of \$20,000.00.
- Manatee County Animal Services shall review and update the bid specifications for groups 1, 4, 5, 6, 7, and miscellaneous catalog items. A revised bid will be re-issued at a later date. In such event, the County will attempt to notify bidders and encourage participation in submitting a bid.
