ADDENDUM 1

Bidders are hereby notified that this Addendum shall be acknowledged on the Bid Form and made a part of the above named bidding and contract documents.

The following items are issued to add to, modify, and/or clarify the bid and contract documents. These items shall have the same force and effect as the original bidding and contract documents, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

1. Information Conference sign-in sheet is attached. The attendees of the previous IFB (17-1207DC) Information Conference were not required to attend this meeting; attached is the Information Conference sign-in sheet for IFB 17-1207DC also.
2. The awarded contract will not require access to the building; however, the Sherriff office will require the names, date of birth, race, and sex of all employees of the contractor who will be working on this project.
3. All roof drains are to remain; but, will require cast iron grates, round tops (not flat).
4. Port-o-let can be placed at the north side of the building.
5. Remove roof hatch, curb, and ladder. If the roof hatch extends above roof, discard ladder. Infill opening with roof deck and insulation to bring to surrounding roof height.
6. An Alternate is added to the Bid Form: In lieu of running the roofing up to the original reglet in the CMU parapet, run the roofing up and over the top of the parapet then topping it with the metal cap flashing. Revised Bid Form is attached. Acceptance of this Alternate shall be at the County's sole discretion. Review shall be included in the County evaluation of the total award amount.
