Authorization to award IFB 17-0101DC, Village of Parrish Force Main and Master Lift Station, to the responsive and responsible bidder having the lowest total cost, Woodruff & Sons, Inc., Bradenton, Florida, for a total of \$6,864,571.34 based on a Bid "B" expedited construction completion time of 540 calendar days and the inclusion of the optional sidewalk work.

Authorize the County Administrator, or his designee, to execute the Agreement and accept and date the Performance and Payment Bonds.

Background Discussion

This new force main and lift station construction is related to the US 301-Erie Road/Old Tampa Road to County Road 675 project and will provide wastewater services to the Village of Parrish area and alleviate the potential future overload of the existing lift station.

Formal competitive sealed bid procedures were followed resulting in a total of four bidders submitting a sealed bid for consideration per the attached tabulation.

The Public Works Department recommends award to the responsive and responsible bidder, having the lowest total cost, Woodruff & Sons, Inc., for (Bid "B") the expedited construction completion time of 540 days.

Budget Resolution B-18-021 transfers \$3,000,000 from reserves in the Sewer Facility Investment Fees fund based on the selected bid for the construction costs of the Village of Parrish Force Main and Master Lift Station associated with the award of IFB 17-0101DC.
