Authorization to award IFB 17-0418DC, 45th Street East Roadway Improvements, to the responsive and responsible bidder having the lowest total cost, Gator Grading & Paving, LLC, Palmetto, Florida, for a total of \$9,838,720.97 based on Bid "A" expedited construction completion time of 540 calendar days and the inclusion of Bid Alternate #2.

Authorize the County Administrator, or his designee, to execute the Agreement and accept and date the Performance and Payment Bonds.

Adopt Budget Resolution B-18-026 transferring \$9,403,744 from the reserves to fund this project.

## Background Discussion

Proposed project for construction to upgrade approximately 1.5 miles of an existing two-lane roadway to a four-lane roadway on 45th Street East from State Road 70 (53rd Avenue East) to 44th Avenue East, including turn lanes, sidewalks, bike lanes, bridge widening, roadway lighting and signalization, and construction of a wastewater

collection system.

Formal competitive sealed bid procedures were followed resulting in a total of seven bidders submitting a sealed bid for consideration per the attached tabulation.

The Public Works Department recommends award to the responsive and responsible bidder having the lowest total cost, Gator Grading & Paving, for (Bid "A") the expedited construction completion time of 540 days.

Budget Resolution B-18-026 transfers funds from the 2016 Transportation Revenue Improvement Note Capital Project fund and from the Roads Impact Fees Capital Project fund based on the selected bid for the construction costs of the 45th Street East Roadway Improvements associated with the award of IFB 17-0418DC.
