NOTICE OF CANCELLATION

Notice is hereby given that Manatee County Government has rejected all proposals submitted and cancelled RFP No. 18-R067560JE. Notice is also given that the County intends to resolicit for these services.

ENABLING/REGULATING AUTHORITY

Federal/State law(s), administrative ruling(s), Manatee County Comp Plan/Land Development Code, ordinances, resolutions, policy.

Pursuant to the Request for Proposals, Section A.16, Reserved Rights, the County is publishing notice of its decision to reject all proposals received in response to the above-referenced RFP and cancel the RFP. Pursuant to F.S. 119.071(1)(b)3, if an agency rejects all replies submitted in response to a competitive solicitation and the agency concurrently provides notice of its intent to reissue the competitive solicitation, the rejected replies remain exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution until such time as the agency provides notice of an intended decision concerning the reissued competitive solicitation or until the agency withdraws the reissued competitive solicitation.

BACKGROUND/DISCUSSION

PROJECT BACKGROUND:

The purpose of this Request for Proposal (RFP) was to obtain a fully Automated Parking Control System for the Manatee County Administration Building Parking Garage. The present parking configuration consists of 470 parking spaces throughout eight (8) parking levels. The County employee parking is above the existing parking gate. The public parking spaces will be located below the parking gate and will have 122 available parking spaces. The project scope will be to configure all 122 public spaces for a fully Automated Parking Control System. This Automated Parking Control System is to be remotely programmable, user friendly, and simple to understand and program.

SOLICITATION:

The RFP was advertised on the Manatee County website, DemandStar, and was also provided to the Manatee County Chamber of Commerce for release to its members. One (1) proposal was received.
