Authorization to award IFB 17-1641DC, Phase III Gas Collection Expansion Lena Road Landfill, to the responsive and responsible bidder having the lowest total cost, Aptim Environmental & Infrastructure, Inc., Baton Rouge, Louisiana, for a total of \$1,434,238.30 based on Bid "A" construction completion time of 120 calendar days.

Authorize the County Administrator, or his designee, to execute the Agreement and accept and date the Performance and Payment Bonds.

Background Discussion

At the Lena Road Landfill, the County has constructed a gas collection system which reroutes the methane emitted from deteriorating buried refuse to be used as energy. This project provides for the expansion of this gas collection system and generally includes the construction of additional gas extraction wells and ties to the existing system.

Formal competitive sealed bid procedures were followed resulting in a total of five bidders submitting a sealed bid for consideration per the attached tabulation.
