NOTICE OF INTENT TO AWARD

The Manatee County Procurement Division provides notice of its intent to award a contract to Granger Maintenance & Construction, Inc., Plant City, Florida, the lowest responsive and responsible bidder, for the rehabilitation of six lift stations for a total bid of \$632,574.80 and 240 calendar days for contract completion.

ENABLING/REGULATING AUTHORITY

Manatee County Procurement Ordinance, Sec 2-26.

BACKGROUND/DISCUSSION

- This project will provide for the rehabilitation and repair of six sewage lift stations that include wet well cleaning and the replacement of: discharge piping, fittings, valves, guide rails, bracings, and ells. The lift stations are identified as: Savannah; Horseshoe Cove 2; Pescara Lakes; Chateau Village; Casa Loma; and Cascades.
- On October 29, 2017, the County issued an Invitation for Bids (IFB) No. 18-TA002592DC for Satellite Lift Station R&S 2016 Group 1. The IFB was advertised in the Bradenton Herald legal ads; on the Manatee County and the DemandStar websites; and was provided to the Manatee County Chamber of Commerce and the Manatee County Black Chamber of Commerce for release to their members. Two bid responses were received for consideration per the attached tabulation from the following:
 1. CEC Motor & Utility Services, Palmetto FL
 2. Granger Maintenance & Construction, Plant City FL
- Procurement and the Public Works Department recommend award to the responsive and responsible bidder having the lowest total cost, Granger Maintenance & Construction, Inc.
- Project will be funded through Utility Rates.
