QUESTIONS AND RESPONSES:

Q1. We are respectfully requesting consideration for an extension of two weeks from the original submission due date of May 25th at 3PM.

R1. Per this Addendum No. 2, the Due Date has been extended until 3:00 P.M., June 1, 2018.

Q2. Tab 2 of Section C, Proposal Response, provides minimum qualifications that the Proposer or Subcontractor(s) must meet, such as, two previous cellular cofferdam projects. By requiring these qualifications, it may require Proposers to team with cofferdam Subcontractors. This may reduce the opportunity to competitively bid this portion of work once the CMAR has been selected. We are requesting that the qualification is altered to state "If the Proposer intends to self-perform the cofferdam work then Proposer shall have completed two cellular cofferdam projects within the last five years, otherwise provide two cofferdam projects within the last five years and a statement that the subcontractor to be selected at a later date will meet the two cellular cofferdam requirement.

R2. The minimum qualification requirements listed in Tab 2 of Section C shall remain as stated in the RFQ. The Proposer (CMAR) must identify the proposed subcontractor(s) for the cofferdam system, if not self-performed, when they submit their proposal as this portion of the work is a minimum requirement. Proposers are permitted to provide a list of multiple proposed subcontractors. As such, the CMAR must provide the qualifying projects required in Section C.02, B. Tab 2, for each proposed subcontractor submitted for either phase of this project for qualifying work items. In order to meet this minimum qualification requirement, CMAR (if work is self-performed) or each of its proposed subcontractors must meet the minimum qualification requirement in C.02, B. Tab 2-Minimum Qualification Requirements


