Clarifications based on questions submitted by Jack Morsink, Westra Contruction:

1. In reference to Addendum #2, please clarify the service items. Page 3 of 4 states that where backflow preventers are installed, bladder tanks are to be installed on the hot water heaters. Does this mean that bid items 6b, 6d, 6f and 6h will require bladder tanks or are the bladder tanks only required in bid item #7a? Are bid items 7a and 7b identifying the only services that will require reconnecting to the existing services? Or do all services require reconnection to the existing as identified in the item 6 description? Do items 7a and 7b refer to only the connections or are they complete services? Must these connections be completed by a licensed plumber?

A revised Bid Form is included in this Addendum.

Revisions to Specifications:

- 1) Section 01150-3 Measurement and Payment.

Please note the following:

Discretionary work is no longer a Bid Item on the Bid Form. Consequently, Bid Items 4 through 9 in the Section should be renumbered to 3 through 8 to coincide with the Bid Form.

- 2) Section 01150 -- Bid Item #7 (Formerly #8)

Replace description with the following:

Payment for all work included in these Bid Items shall be made at the applicable Contract unit price bid per each reconnection type for furnishing and installing the listed individual services lines, and connection of the new service lines to existing service lines as shown on the Contract Drawings and listed on the Bid Form. Two Bid Items have been

provided. Bid Item 7a includes furnishing and installing a backflow preventer on the service line and a bladder tank on the residential hot water heater. These two items are not required for Bid Item 7b. All work shall conform to the requirements of the Manatee County Building Department. Payment shall represent full compensation for all labor, material, excavation, including rock, bedding, backfill, compaction, testing and disinfection, surface restoration and equipment required to complete these Bid Items. In addition, the contractor is required to obtain a building permit for each on-site services installed. A fee of \$75.00 per permit should be included.
