1. Changed: Item No. 327-70 Group 1 (Orange Ridge) Unit Measure changed from ~~LS~~ to SY.
2. Changed: Item No. 327-70 Group 2 (Overstreet Park) Unit Measure changed from ~~LS~~ to SY.
3. Changed: Item No. 327-70 Group 3 (Sunny Lakes) Unit Measure changed from ~~LS~~ to SY.

QUESTIONS AND RESPONSES:

Q1. Will the County be able to provide the length and widths of each street that is to be milled and paved?

R1. It is the Contractor's/Bidder's responsibility to verify all measurements as indicated on the Plan Set/Drawings for each group.

Q2. On Sheet 5 of the Sunny lakes (Group 3) Plan set, Note 2 states, "All price determination for materials, labor and equipment will be bid as lump sum for each group. This lump sum bid is to include but not limited to mobilization, maintenance of traffic, clean up, sweeping, resident notification, etc. that will complete these groups. Awards will be to the lowest lump sum bid for each group." It appears that from the bid form listed in "Appendix J" from the "Invitation For Bid", that this project is to be a unit price contract, but the note as stated above contradicts it. Is this project to be bid as lump sum or as unit price?

R2. Note 2 on Plan Sheet 5 for Sunny Lakes (Group 3) is deleted by this Addendum No. 1 as indicated above.

Q3. On Page 76 Appendix A, "Bidder's Questionnaire" there are 3 questions that pertain to Drilling Supervisor Qualifications, Pipe Fusion Qualifications, and Pipe Bursting Qualifications. Will these questions need to be answered if they aren't applicable to the project?

R3. If a question is not applicable to the Scope of Work requested in the solicitation, please indicate "Not Applicable" in the allocated field.

Q4. In the Invitation for Bid packet, "Appendix J" list's all the bid items and their quantities. Are all the milling items for each group to be bid as lump sum or are they to be bid by the square yard?

R4. These items should be bid by square yard (SY). Please see attached revised Appendix J Bid Form.

Q5. In reference to Section B, note B.02 "Completion of work", if only one or two groups are awarded does the same 30-day contract time still apply?

R5. Yes.

Q6. On sheet 2 of project plans, note 2 states that "Site visits are mandatory for all bidders. These site visits can be arranged through the project manager." Please clarify if bidders will need documentation from the project manager to prove that a site visit had been arranged and completed?

R6. Bidders must submit a statement on company letterhead signed by an authorized official of the Bidder, that Bidder or its representative(s) has inspected the construction site listing, the date of the inspection, and the individuals by name who conducted the inspection.

NOTE: Items that are ~~struck through~~ are deleted. Items that are underlined have been added or changed. All other terms and conditions remain as stated in the 18-TA002778JP.
