NOTICE OF INTENT TO AWARD

The Manatee County Procurement Division provides notice of its intent to award a contract with Battery USA, Inc. for the provision of obtaining automotive batteries with inventory management services.

ENABLING/REGULATING AUTHORITY

Manatee County Procurement Ordinance, Sec 2-26.

BACKGROUND/DISCUSSION

The purpose of this ITQ is to establish a multi-year agreement for on-going delivery of automotive batteries including recycling of old stock and replacing old stock with new stock while maintaining required stock levels.

The solicitation was directly solicited to seven local vendors . Responses were received from the following firms:

1. Battery USA, Inc., Sarasota, FL
2. Genuine Automotive Supply, Inc., Bradenton, FL
3. Interstate Batteries of Sarasota, Sarasota, FL
