

### NOTICE OF INTENT TO NEGOTIATE FOR AWARD

The Manatee County Procurement Division provides notice of its intent to award a single source contract with a value of \$78,970.00 with EnviroBuild, LLC., for the provision of construction of a street hockey rink foundation and concrete slab.

### BACKGROUND/DISCUSSION

Manatee County Procurement Division has completed a due diligence review and intends to procure the construction of a concrete slab for street hockey rink from EnviroBuild, LLC., without conducting a competitive solicitation process for the following reason(s).

Manatee County entered into an Agreement with Lightning Foundation, Inc. (LF), to work cooperatively in designing and performing the installation of a street hockey rink at the Lakewood Ranch Park Complex. As per the Agreement with LF, the County is responsible for preparing the foundation and constructing the concrete slab for the hockey rink deck.

LF is using EnviroBuild, LLC., to construct their portion of the street hockey rink. To keep seamless construction efforts, the County also recommends to use EnviroBuild, LLC for the construction of the foundation and concrete slab.
