Bids must be delivered to the following location: Manatee County Administration Building, 1112 Manatee Ave. W., Suite 803, Bradenton, FL 34205 and time stamped by a Procurement representative prior to the Due Date and Time.

QUESTIONS AND RESPONSES:

- Q1. Will Mueller valves be a part of the approved products list for both resilient wedge gate valves and tapping valves if the hardware for the valve is 316SS and stem does NOT have a break groove? R1. Yes.
- Q2. Will the Ford 202B saddles be added back to the approved products list? R2. Yes.

- Q3. Will the County consider offering (currently stocked) manufacturer part numbers for corresponding bid material?
- R3. The County currently does not have this information. If there is an issue with certain items, we will assist as needed.
- Q4. Is the Agreement term 1 year (annually) or 3 years?
- R4. The initial term is three years with two one-year renewal options.
- Q5. Do Bidders have to fill in every line item per group to be considered for material award (responsive)?
- R5. No. Multiple award(s) will be issued based on the lowest quote per item, not by group.
- Q6. In Exhibit 1, Scope of Work, Section C.09, Price Escalation/De-escalation, 2nd paragraph, page 61, what is meant by "Case by Case basis"?
- R6. If a tariff increases manufacturer costs, thereby increasing Bidders' costs, Bidder will need to include a letter from the manufacturer(s) verifying how much of an increase their costs increased and when the increase occurred, along with Bidder's proposed increase. If and when the tariff is rescinded, then the awarded increase as a result of the tariff would also be rescinded.

NOTE: Items that are struck through are deleted. Items that are underlined have been added or changed. All other terms and conditions remain as stated in the IFB.
