3. Proposer or its subcontractor has completed (which means that certificate of occupancy has been issued) a minimum of three (3) library design-build projects since 2010. The three (3) qualifying projects could have been constructed using either design-bid-build, construction manager at risk, or design-build methods, so long as the architect/engineer and the contractor for those three qualifying projects are part of the Proposer's design-build team. Provide the following information for each qualifying project.
  - a) Identify who was contracted to complete the project (Proposer or its subcontractor)
  - b) Project name and location
  - c) Client/Organization name
  - d) Contact name
  - e) Contact phone
  - f) Contact email
  - g) Project dates (Start/End)
  - h) Construction method (design-bid-build, CMAR, or design-build)
  - i) Name of Architect/Engineer firm

**QUESTIONS AND RESPONSES:**

**Q1. First, page 49 of the RFP (page 2 of Attachment B) says "Proposer or its subcontractor has completed (which means that certificate of occupancy has been issued) a minimum of three library design-build projects since 2014." Is the evaluation committee willing to consider alternative D/B projects or alternative library experience, in addition to solely D/B library projects?**

R1. Yes, see revisions to Section B.3 of Attachment B above in this Addendum 2.

**Q2. Second, on page 53 of the RFP (page 6 of Attachment B) it says "Provide a list of up to five design-build projects, particularly those of library facilities which Proposer has successfully completed since 2010. At least one project should be one that the Proposer's design-build team has constructed together." Would the evaluation committee consider library projects that the team has constructed together that are not D/B?**

R2. Yes, clearly state team member relationships and roles.
