Change to:

BID ATTACHMENT 2, SCOPE OF WORK, SECTION 1.04, SERVICE REQUIREMENTS, PARAGRAPH A, ITEM (6)(a)

6.a. Remove a 220' section of the boardwalk (all lumber and hardware except pilings).

Change to:

APPENDIX A, MINIMUM QUALIFICATIONS, ITEM 1

1. Must have been registered with the State of Florida, Division of Corporations to do business in Florida for the past three years, since January 1, 2017.

No documentation is required. The County will verify registration.

Change to:

APPENDIX A, MINIMUM QUALIFICATIONS, ITEM 3

3. Must have possessed a Certified General Contractor's or Certified Specialty Marine Contractor's License, issued by the Florida Department of Business and Professional Regulation for a period of at least three consecutive years since January 1, 2017.

License must be current and valid through the Due Date for submission of bids for this IFBC.

Provide a copy of Bidder's General Contractor's or Certified Specialty Marine Contractor's License, issued by the Florida Department of Business and Professional Regulation and documentation confirming Bidder has been licensed and/or certified for the period of January 1, 2017 through the date of submission of the Bid.

Change to:

APPENDIX A, MINIMUM QUALIFICATIONS, ITEM 4

4. Bidder has provided boardwalk repair services for at least three clients since January 1, 2015 in which each project included one or more of the following components: (a) repair or installation of fixed docks over a body of water; (b) repair or installation of floating docks over a body of water; and/or (c) repair or installation of boardwalks in a nature preserve.
