The Manatee County Procurement Division provides notice of its intent to award a contract with McCulley Marine Services, Inc. for the provision of and installation of a limestone boulder artificial reef at the Borden Site in the Gulf of Mexico.

BACKGROUND/DISCUSSION

Manatee County has obtained a grant from the Fish and Wildlife Conservation Commission to establish an artificial reef at the Borden Site off the coast of Manatee County in the Gulf of Mexico. For this purpose, Invitation to Quote No. 20-R073120GE was advertised.
