SECTION A: INFORMATION TO PROPOSERS

PROPOSERS MUST COMPLY WITH THE FOLLOWING INSTRUCTIONS TO BE CONSIDERED FOR SELECTION.

A.01 OPENING LOCATION

Each proposer shall examine all Request For Proposal documents and shall judge all matters relating to the adequacy and accuracy of such documents. Any inquiries, suggestions or requests concerning interpretation, clarification or additional information pertaining to the Request For Proposal shall be made in writing through the Manatee County Purchasing Office. The County shall not be responsible for oral interpretations given by any County employee, representative, or others. A.06 LEGAL NAME

Proposals shall clearly indicate the legal name, address and telephone number of the proposer (company, firm, partnership, individual). Proposals shall be signed above the typed or printed name and title of the signer. The signer shall have the authority to bind the proposer to the submitted proposal.

A.07 PROPOSAL EXPENSES

All expenses for making proposals to the County are to be borne by the proposer.

A.08 EXAMINATION OF OFFER

The examination of the proposal and the proposer generally requires a period of not less than ninety (90) calendar days from the date of the opening of the proposals.

A.09 DISCLOSURE

Proposals become "Public Records" ten (10) days after the proposal opening or if an award decision is made earlier than this time as provided by Florida Statute 110.071. No review of the proposal documents shall be conducted at the public opening of the proposals.

Manatee County will make public at the opening the names of the business entities of all that submitted an offer and any amount presented as offers by location without any verification of the mathematics or the completeness of the offer.

A.10 ERRORS OR OMISSIONS

Once a proposal is submitted, the County shall not accept any request by any proposer to correct errors or omissions in the proposal. No changes shall be allowed until a selection is made and contract negotiations actually begin.

A.11 RESERVED RIGHTS

The County reserves the right to accept or reject any and/or all proposals, to waive irregularities and technicalities, and to request resubmission. Any sole response received by the first submission date may or may not be rejected by the County, depending on available competition and timely needs of the County. The County reserves the right to award the contract to a responsible proposer submitting a responsive proposal, with a resulting negotiated agreement which is most advantageous and in the best interests of the County. The County shall be the sole judge of the proposal, and the resulting negotiated agreement that is in its best interest and its decision shall be final. Negotiated Agreements may or may not include all elements of this RFP or the resulting successful proposal where alternative terms or conditions become more desirable to the County, and the parties agree to such terms. Also, the County reserves the right to make such investigation as it deems necessary to determine the ability of any proposer to perform the work or service requested. Information the County deems necessary to make this determination shall be provided by the proposer. Such information may include, but shall not be limited to: current financial statements prepared by an independent CPA; verification of availability of equipment and personnel; and past performance records.

A.12 APPLICABLE LAWS

Proposer must be authorized to transact business in the State of Florida. All applicable laws and regulations of the <u>State of Florida</u> and ordinances and regulations of Manatee County will apply to any resulting agreement. Any involvement with any Manatee County procurement shall be in accordance with <u>Manatee County Code of Laws 2-26</u>, as amended. Any actual or prospective proposer who is aggrieved in connection with the solicitation or award of a contract may protest to the Board of County Commissioners of Manatee County as required in Chapter 2-26-61 of the Manatee County Code of Laws.

A protest with respect to this Request For Proposal shall be submitted in writing prior to the scheduled opening date of this proposal, unless the aggrieved person did not know and could not have been reasonably expected to have knowledge of the facts giving rise to such protest prior to the scheduled opening date of this proposal. The protest shall be submitted within seven calendar days after such aggrieved person knows or could have reasonably been expected to know of the facts giving rise thereto.

A.13 CODE OF ETHICS

With respect to this proposal, if any proposer violates or is a party to a violation of the <u>Code of Ethics</u> of Manatee County per Manatee County Code of Laws, Article III, Ethics in Public Contracting, and/or the state of Florida per Florida Statutes, Chapter 112, Part III, Code of Ethics for Public Officers and Employees, such proposer may be disqualified from performing the work described in this proposal or from furnishing the goods or services for which the proposal is submitted and shall be further disqualified from submitting any future proposals for work or for goods or services for Manatee County.

The County anticipates that all statements made and materials submitted in a proposal will be truthful. If a bidder or proposer is determined to be untruthful in its proposal or any related presentation, such bidder or proposer may be disqualified from further consideration regarding this Request for Proposals.

A.14 COLLUSION

By offering a submission to this Request For Proposal the proposer certifies the proposer has not divulged to, discussed or compared his proposal with other proposers and has not colluded with any other proposer or parties to this proposal whatsoever. Also, the proposer certifies, and in the case of a joint proposal, each party thereto certifies, as to their own organization that in connection with this proposal:

a. any prices and/or data submitted have been arrived at independently, without consultation, communication or agreement, for the purpose of restricting competition, as to any matter relating to such prices and/or cost data, with any other proposer or with any competitor;

A.14 COLLUSION (CONTINUED)

- any prices and/or cost data quoted for this proposal have not been knowingly disclosed by the proposer prior to the scheduled opening directly or indirectly to any competitor;
- no attempt has been made or will be made by the proposer to induce any other person or firm to submit or not to submit a proposal for the purpose of restricting competition;
- d. the only person or persons interested in this proposal as principal or principals is/are named therein and that no person other than therein mentioned has any interest in this proposal or in the contract to be entered into; and
- e. no person or agency has been employed or retained to solicit or secure this contract upon an agreement or understanding for a commission, percentage, brokerage, or contingent fee, excepting bona fide employees.

A.15 PROPOSAL FORMS

Proposals must be submitted in the format specified in Section B hereof. The contents of each proposal shall be separated and arranged with tabs in the same order as listed in the Subsections within Section B identifying the response to each specific item thereby facilitating expedient review of all responses.

A.16 PUBLIC ENTITY CRIMES

In accordance with Section 287.133, Florida Statutes, a person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a proposal on a contract to provide any goods or services to a public entity, may not submit a proposal on a contract with a public entity for the construction or repair of a public building or public work, may not submit proposals on leases or real property to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017 for Category Two (as of 7/1/2010 is \$35,000) for a period of 36 months from the date of being placed on the convicted vendor list. **Proposer is to complete Attachment "D"**

A.18 LOBBYING

After the issuance of any Request For Proposals, prospective proposers or any agent, representative or person acting at the request of such proposer shall not contact, communicate with or discuss any matter relating in any way to the Request For Proposals with any officer, agent or employee of Manatee County other than the Purchasing Official or as directed in the Request For Proposals. This prohibition begins with the issuance of any Request For Proposals and ends upon execution of the final contract or when the request has been canceled. Violators of this prohibition shall be subject to sanctions as provided in the Manatee County Procurement Code.

<u>B.01</u> <u>MINIMUM QUALIFICATIONS:</u> The Proposer must present qualifications and capabilities as follows prior to further consideration of their proposal:

Identify the person that is the qualifying agent for the proposer who currently and for the duration of the engagement shall maintain the Florida General Contractors license along with a copy of all applicable and current licenses.

The Business Entity submitting the proposal must present for evidence of their past experience and expertise in performing similar type projects that require knowledge of working on structures of historical significance including those, if any, listed on a State of Florida or National Historical Register.

The Business Entity submitting the proposal must be capable of providing a performance and Payment Bond for this project.

To validate the experience, expertise and capabilities provide the following:

- A. The Florida City or County where the project or projects are located.
- B. Name of the entity that issued the contract, be it government or private.
- C. Name of the Project as shown on the executed contract.
- D. The Commencement and Completion date of the project and the duration was it completed on time and within budget?
- E. Elements of work performed on the project.
- F. Owner's contact including person responsible for the administration of the contract and contact information including telephone and email information.
- G. Statement on surety company letterhead of the **unencumbered bonding capacity** for your business entity and a statement that a 100% Performance and Payment Bond for this project will be issued to Manatee County upon request.

After Manatee County staff validates the Minimum Qualifications given, those proposers who meet the minimum qualifications stated will be considered.

- b. Provide an **explanation of the business entity which you represent**. Specify the business entity which would be bound by a contract, should your firm be selected: company or corporation; subcontractor roles; and if a joint venture, include the specific experience that the joint venture partners have working together on similar projects.
- c. Identify each **principal of the firm and other "key personnel"** who will be actively associated with the County. <u>Do not include personnel that will not have a role in this project</u>. Describe their respective areas of expertise. Include personalized resumes which identify the qualifications, training and experience of each key personnel. - d. Submit a list of **subcontractors and/ or sub-consultants** that may be used with the same level of detail as item B.03 c above, including their intented roles in the project.
- e. Specify the office and the location of the business entity explained in response to item b and item d above which is to be the primary location of the principal and key personnel. List the key personnel at that location. For the remaining key personnel detail at what location(s) they will work from and how they will provide management or service or supply support from the locations that they will work from.

B.03 INFORMATION TO BE SUBMITTED (CONTINUED)

f. Submit a narrative **explaining the direct economic benefit to Manatee County to be realized by selecting your firm.** During the term of this engagement detail the employment, subcontracting, and support services contracting as economic stimulus that your entity may generate that would directly benefit Manatee County.

- h. Provide a **schedule of anticipated elements** of work to be performed and a **total number of days required to complete the project** after the issuance of a Notice to Proceed. Further include a narrative of how your entity will accomplish the staging and phasing required in the Request for Proposal.

B.04 ESTIMATED PROJECT COSTS

Proposer shall provide a cost proposal using the response to B.03 (h)"Schedule" for the project with detailed costs for the identified elements of work based on the information provided within this Request For Proposal. The elements of the proposed cost shall be developed and presented separately as follows:

- A. Façade Cost Estimate with Schedule of Values
- B. Window Replacement Cost Estimate with Schedule of Values
- C. Roof Replacement (including lighting protection) Cost Estimate with Schedule of Values
- D. Tuck-pointing of Mechanical Penthouse and repairs to Façade as noted sheet D-7.1 & 7.2- Cost Estimate with Schedule of Values
- E. Tuck-pointing Alternate Pricing: See E.03, Item 3

B.04 ESTIMATED PROJECT COSTS (CONTINUED)

The estimates shall include, but not limited to, all labor, payroll taxes, material, equipment, safety devices and practices required by OSHA, Public Safety components i.e. covered walkways, barricades, e.t.c., subcontractors, consultants, overhead, profit, insurance, Workman's Compensation, sales taxes, performance and payment bond, all required permits and any other cost necessary that are typically and normally provided and accepted in the best construction practices to complete the project.

B.05 ADDITIONAL INFORMATION NOT REQUESTED

Submit any other additional information which would assist the County in the evaluation of your proposal.

The County reserves the right to make any investigation and solicit additional information or submittals as it deems necessary to determine the ability of any Proposer to perform the Scope of Services stated in this Request for Proposal.

SECTION C: SELECTION

C.01 EVALUATION FACTORS

Evaluation factors are (1) the perceived ability of the Proposer to perform the Scope of Services as stated in this Request for Proposal in the most timely and efficient manner, and (2) the estimated cost proposed. These evaluation factors shall determine the proposal which will overall best meet the needs of Manatee County as determined from the responses to this Request for Proposal and subsequent investigation by the County.

C.02 RELATIVE IMPORTANCE OF EVALUATION FACTORS

No weight has been assigned to the Evaluation Factors stated above.

C.03 PRELIMINARY RANKING

A Selection Committee may determine from the responses to Section B: Form of Proposal of this Request for Proposal and subsequent investigation as necessary, the Proposers most susceptible of being selected for award.

C.04 REVIEW OF PROPOSERS AND PROPOSALS

Review may be conducted with responsible Proposers who may be reasonably susceptible of being selected for award, for the purposes of clarification to assure full understanding of and conformance to the solicitation requirements, the abilities of the Proposer, and the proposal submitted.

Firms responding to this Request for Proposal shall be available for presentation/interviews, to the Selection Committee upon notification from the Purchasing Office at a time and date determined by the County.

C.05 SELECTION FOR NEGOTIATION

The Proposer whose ability and proposal is determined to be the most advantageous to the County, taking into consideration the evaluation factors set forth in this Request for Proposal, shall be selected to negotiate an agreement for the stated Scope of Services.

C.06 AWARD

Award of an agreement is subject to the successful negotiations and the vote of the Board of County Commissioners to authorize execution of the agreement.

SECTION D: NEGOTIATION OF THE AGREEMENT

D.01 GENERAL

The following general terms and conditions apply to the proposal submitted for consideration and the subsequent negotiations:

- a. The proposal will serve as a basis for negotiating an agreement.
- b. Upon submission, all proposals become the property of the County which has the right to use any or all ideas presented in any proposal submitted in response to this Request for Proposal whether or not the proposal is accepted.
- c. All products and papers produced in the course of this engagement become the property of the County upon termination or completion of the engagement.

D.02 AGREEMENT

The selected Proposer shall be required to negotiate a formal agreement, in a form acceptable to Manatee County.

Negotiated Agreements may or may not include all elements of this RFP or the resulting successful proposal where alternative terms or conditions become more desirable to the County, and the parties agree to such terms.

The Manatee County Board of County Commissioners will be presented the negotiated agreement as the best and final offer for consideration of award and execution. The Board of County Commissioners shall determine if award of the agreement is to be: considered; rejected and direct further negotiations; rejected and terminate negotiations; or accepted, authorizing the County Administrator or his designee to execute the agreement.

SECTION E: SCOPE OF SERVICES

E.01 Background Information:

The Manatee County Historic Courthouse is an existing 4 story building clad in masonry and constructed with concrete, originally built in 1913. The building has had 2 major additions with the last addition occurring in 1965. The building's existing masonry exterior facade consists of face brick and a decorative projecting terracotta and concrete cornice, topped with a masonry parapet, which is also capped with concrete sections. Due to improper wall detailing, poor grouting details, improper anchorage materials and lack of proper maintenance, the exterior facade has been infiltrated with water intrusion, causing deterioration of the facade. The existing parapet will need to be removed in order to remove the cornice and correct the water intrusion. New light weight fiber glass cornice units will be fabricated to replicate the original profiles and color, while reducing the overall weight on the structure, while the parapets rebuilt with thru-wall flashings. The exterior face brick will be tuck-pointed where it is determined necessary to further reduce water intrusion. New wall flashings will be used at window heads to redirect the water to the exterior so that further water intrusion is eliminated.

The existing roof was designed with a typical built-up tar and gravel roof system. Over the years, roof leaks occurred which prompted the addition of extra layers of built-up tar and gravel layers, in an attempt to stop the water intrusion. Currently, there are approximately 3 to 5 layers of tar and gravel roof layers in some areas which are now holding water and adding unwanted weight to the structure. The remedy is to remove all the layers of the existing roofing and replace the original system with a new membrane roof system which is intended to also have energy savings.

The original double hung windows were replaced with new single pane aluminum awning windows throughout the entire structure during the 1965 building addition. The existing aluminum windows are now leaking and the existing glazing has deteriorated causing the glass to slip down in the frames. New double hung aluminum window units have been designed to replicate the original 1913 exterior appearance and shall contain low E reflective impact glass to both reduce heat infiltration, while satisfying County wide compliance with building hardening requirements.

E.02 SCOPE OF SERVICES - Miscellaneous

The proposer shall be aware of and responsible for the following:

- 1. Coordinate and cooperate with other Manatee County Contractors performing other work unrelated to this RFP.
- 2. The Building will be occupied during the performance of this project, all interruptions to utilities of any kind shall be scheduled no less than one week in advance.
- 3. Proposer shall be responsible for all dry-in of the structure and insure the facility is dry and secure at all times.
- 4. The building is a secured facility and access cards, ten (10), will be issued to the proposer which will be utilized at the proposers' discretion. Background checks for <u>ALL</u> personnel should be anticipated by the proposer and the proposers' subcontractors and the cost for same including Photo Identification badges shall be the responsibility of the Proposer. Proposer shall be subject to the Clerk of Court's security protocol.
- 5. The proposer shall consider in his cost proposal that the site lacks any type of storage area.
- A construction office area shall be provided to the proposer within the basement area of the facility with an outside access entrance door, office to be furnished by the proposer.
- 7. Site signage will conform to County signage standards.

- 3. Tuck-pointing Alternate Pricing: Exclusive of the Penthouse tuck-pointing the proposer shall inspect the remaining masonry elevations of the structure and provide an estimated cost to tuck-point areas that are discovered to have deteriorated or missing mortar joints.

This alternate shall follow the same tuck-pointing specification that is provided for the Penthouse.

EO.4 Ownership and Use of Documents:

It is understood and agreed that the documents or reproducible copies, including reports, designs, specifications, other documents and data developed by the Proposer, the County, or the County Consultants in connection with this RFP and the Project shall be delivered to and shall become the property of the County as they are received by the County. The Proposer hereby assigns all its copyright and other proprietary interests in the products of the agreement to the County. Specific written authority is required by the County's Administrative Agent for the Proposer to use any of the work products of this REQUEST FOR PROPOSAL or any future agreement on any non-County project.

E.05 MEETING REQUIREMENTS

Proposer shall conduct and chair weekly, on-site, project meetings with all subcontractors, and provide the County a written summary of each weekly meeting. These reports shall be submitted to the County Project Manager within three calendar day of the occurrence of the latest meeting.

E.06 INSURANCE:

- 1) Insurance: Before performing any contract work, the Proposer shall procure and maintain, during the life of the agreement unless otherwise specified, insurance listed below. The policies of insurance shall be primary and written on forms acceptable to the County and placed with insurance carriers approved and licensed by the Insurance Department in the State of Florida.
- 2) Workers' Compensation: Proposer shall provide Workers' Compensation Insurance, on behalf of all employees who are to provide a service under this agreement as required under Florida Law.
- 3) Commercial General Liability including but not limited to bodily injury, property damage, contractual, products and completed operations, and personal injury with limits of not less than \$1,000,000 per occurrence, \$1,000,000 aggregate covering all work performed under this agreement.
- 4) Umbrella Liability with limits not less than \$2,000,000 per occurrence covering all work performed under this agreement.
- 5) All policies required by this agreement, with the exception of Workers' Compensation, or unless specific approval is given by County Risk Management, are to be written on an occurrence basis, shall name the Board of County Commissioners, its officers, agents, employees and volunteers as additional insured as their interest may appear under this agreement. Insurer(s), with the exception Workers' Compensation, shall agree to waive all rights of subrogation against Manatee County, it Commissioners, officers, agents, employees or volunteers.

E.06 INSURANCE: (CONTINUED)

- 6) Each insurance policy required by this agreement shall:
 - a) Apply separately to each insured against whom claim is made and suit is brought, except with respect to limits of the insurer's liability.
 - b) Be endorsed to state that coverage shall not be suspended, voided or canceled by either party except after thirty (30) calendar days prior written notice by certified mail, return receipt requested, has been given to County Risk Management.
- 7) The procuring of required policies of insurance shall not be construed to limit the Proposer's liability nor to fulfill the indemnification provisions and requirements of this agreement.
- 8) Certificates of Insurance evidencing Claims Made or Occurrence form coverage and conditions of this agreement, as well as the contract number and description of work, are to be furnished to County Risk Management prior to commencement of work. All insurance certificates shall be received by County Risk Management before the Proposer will be allowed to commence or continue work.

MANATEE COUNTY LOCAL PREFERENCE LAW AND VENDOR REGISTRATION

F.02 Section 2-26-6. Local preference, tie bids, local business defined.

- (a) Whenever a responsible local business bidder and a responsible non-local business bidder are found, upon the opening of bids, to have both submitted the lowest responsive bid, the bid of the local bidder shall be awarded the contract. Should more than one responsible local business bidder match the responsible non-local business bidder's lowest responsive bid, or should no responsible local business bidder match the lowest responsive bid but two or more responsible non-local business bidders submit lowest responsive bids for equal amounts, then the award of the contract shall be determined by a chance drawing, coin toss, or similar tie-breaking method conducted by the purchasing office and open to the public. Any bidders seeking to be recognized as local businesses for purposes of this local business preference provision may be required by the terms of the bid announcement to certify they meet the definition of local business set forth in this section, and to register as a local business with the county in the manner prescribed by the county to facilitate the county's ability to track the award of contracts to local businesses and to allow the county to provide future notifications to its local businesses concerning other bidding opportunities.
- (b) Nothing herein shall be deemed to prohibit the inclusion of requirements with respect to operating and maintaining a local place of business in any invitation for bids when the bidder's location materially affects the provisions of the services or supplies that are required by the invitation.
- (c) Local business is defined as a business legally authorized to engage in the sale of the goods and/or services to be procured, and which certifies within its bid that for at least six (6) months prior to the announcement of the solicitation of bids it has maintained a physical place of business in Manatee, Desoto, Hardee, Hillsborough, Pinellas or Sarasota County with at least one full-time employees at that location.
- (d) Each solicitation for bids made by the county shall contain terms expressly describing the local business preference policies of the county, and shall provide that by electing to submit a bid pursuant to a request for bids, all bidders are deemed to understand and agree to those policies.
- (e) For all contracts for architecture, professional engineering, or other professional services governed by Florida Statute § 287.055, the Consultants' Competitive Negotiation Act, the county shall include the local business status of a firm among the factors considered when selecting which firms are "most highly qualified." In determining which firm is the "most qualified" for purposes of negotiating a satisfactory contract, preference shall be given to a local business where all other relevant factors are equal.
- (f) Local preference shall not apply to the following categories of contracts:
 - 1. Goods or services provided under a cooperative purchasing agreement or similar "piggyback" contract;
 - 2. Contracts for professional services subject to Florida Statute § 287.055, the Consultants' Competitive Negotiation Act, except as provided for in subsection (e) above;

F.02 Section 2-26-6. Local preference, (CONTINUED)

- (f) Local preference shall not apply to the following categories of contracts continued)
 - 3. Purchases or contracts which are funded, in whole or in part, by a governmental or other funding entity, where the terms and conditions of receipt of the funds prohibit the preference;
 - 4. Purchases or contracts made pursuant to a non-competitive award process, unless otherwise provided by this section;
 - 5. Any bid announcement which specifically provides that the general local preference policies set forth in this section are suspended due to the unique nature of the goods or services sought, the existence of an emergency as found by either the county commission or county administrator, or where such suspension is, in the opinion of the county attorney, required by law.
 - (g) To qualify for local preference under this section, a local business must certify to the County that it:
 - 1. Has not within the five years prior to the bid announcement admitted guilt or been found guilty by any court or state or federal regulatory enforcement agency of violation of any criminal law, or a law or administrative regulation regarding fraud;
 - 2. Is not currently subject to an unresolved citation or notice of violation of any Manatee County Code provision, except citations or notices which are the subject of a current legal appeal, as of the date of the bid announcement;
 - 3. Is not delinquent in the payment of any fines, liens, assessments, fees or taxes to any governmental unit or taxing authority within Manatee County, except any such sums which are the subject of a current legal appeal.
